Multi-Agency Uniformed Police Patrol Program - Directive 151040

Per Resolution R-340-15, the following information is provided in response to Commissioner Audrey M. Edmonson's request that the administration provide a written report outlining the development of a Multi-Agency Uniformed Police Patrol Program consisting of Miami-Dade County (County) and municipal police officers to jointly patrol certain high crime areas in the County, irrespective of jurisdictional boundaries; identify available funding sources within the County budget to implement such a program; identify areas in the County that would benefit from such program; and identify municipalities to participate in the program and negotiate any necessary agreements with such municipalities, subject to approval by the Board of County Commissioners.

The Miami-Dade Police Department (MDPD) has numerous inter-agency partnerships with federal, state, and local agencies that are invaluable to the County's overall crime prevention and enforcement efforts. At this time, these partnerships do not include a Multi-agency Uniformed Patrol Program because of the County's current Mutual Aid Agreements (MAAs) with the municipalities that allow for emergency assistance and voluntary cooperation across jurisdictional boundaries, including uniformed police patrol services (see list of municipalities and agencies attached). Due to the County's existing MAAs, police agencies in the County provide multi-agency/multi-jurisdictional uniformed police patrol services throughout the County upon request from the agency or agencies in need.

MAAs provide services such as joint multi-jurisdictional criminal investigations, joint training, off-duty special events, assistance in emergency situations, transportation of evidence that requires security, and other police services, as requested, across jurisdictional boundaries. Under the County's current MAAs, each agency has a supervisor from their respective employing agency that is responsible for the actions of the employees while performing outside their employing agency's jurisdiction. Therefore, the employing agency remains responsible for the management, supervision, training, and liability of its employees while operating outside its jurisdiction, which eliminates concerns regarding accountability.

Routine patrol operations often and unpredictably result in additional law enforcement activities being required such as preserving active crime scenes, arresting and transporting subjects, investigating violations of the law, and collecting and processing

evidence. Therefore, once engaged in the routine police services outside their jurisdiction, those police officers involved may have duties to complete that could cause them to be unavailable to go back into service in their employing jurisdiction for some time.

The respective leaders of the North Miami, Miami Gardens, and Opa-locka Police Departments were contacted for their input on the proposed Multi-Agency Uniformed Police Patrol program. The collective opinion was that, under the current framework of the existing MAAs and the current positive working relationships that they maintain with the County, there is no need for such a Multi-Agency Uniformed Police Patrol Program.

The County's current MAAs provide a viable approach for municipal law enforcement agencies to render reciprocal police assistance within the County. In addition, the present delivery of the law enforcement services within the County utilizes uses a collaborative approach, as evidenced by the deployment of the Multi-Agency Gang Task Force, the MDPD Homicide Bureau's Violent Crime Task Force, Robbery Intervention Detail, and the Wolf Pack Task Force. These crime abatement measures all employ the use of multi-agency/multi-jurisdictional crime-fighting strategies, resources, equipment, and personnel.

Per Ordinance 14-65, this report will be placed on the next available Board of County Commissioners meeting.
