Recommendation for Approval to Access a Florida Sheriffs Association Contract for

Police Rated, Administrative, Utility Vehicles, Trucks and Vans

Recommendation

It is recommended that the Board of County Commissioners (Board) approve accessing a competitively established Florida Sheriffs Association contract, FSA16-VEL24.0, for purchase of police rated, administrative, utility vehicles, trucks and vans for various County departments. This contract was the result of a cooperative bid program designed to benefit public entities in the State of Florida, such as local governments, police agencies and state universities and colleges, by aggregating volume to strengthen purchasing power.

The requested allocation will be used to purchase fleet vehicles for Fiscal Year 2016-17. The vehicles are required to support the operations of County departments and will replace aging fleet that are beyond their useful life. Market research indicates that accessing this contract is in the County's best interest as it was competitively bid and provides the lowest prices found for the needed fleet. Financing for these vehicles will be handled by the Finance Department through a separate agenda item that will be submitted for Board approval. The departmental requests are enumerated below.

- 1) Animal Services is requesting \$60,000 in expenditure authority to procure two (2), ½ ton 4x2 pickup trucks;
- 2) Aviation is requesting \$3,275,000 in expenditure authority to procure 91 pickup trucks, 18 sedans, one (1) mini-van, one (1) compact SUV, and eight (8) Police motorcycles;
- 3) Board of County Commissioners is requesting \$27,000 in expenditure authority to procure one (1), ½ ton 4x2 pickup truck;
- 4) Corrections and Rehabilitation is requesting \$4,154,000 in expenditure authority to procure 24 police pursuit sedans; 54 conventional sedans; 10 hybrid sedans; six (6) heavy cargo vans; three (3) 15-passenger vans; five (5) mini-cargo vans; six (6), ½ ton 4x2 pickup trucks; two (2), ¾ ton 4x2 pickup trucks; two (2) prisoner transport wheelchair vans; seven (7) police package sport utility vehicles; and 26 prisoner transport vans;
- 5) Elections is requesting \$75,000 in expenditure authority to procure three (3) hybrid sedans;
- 6) Fire Rescue is requesting \$1,059,000 in expenditure authority to procure 15 compact 4x2 sport utility vehicles; three (3) police package sport utility vehicles; two (2), ¾ ton 4x4 pickup trucks; 13, ½ ton pick-up trucks; two (2) conventional sedans; two (2), one-ton 4x4 pickup trucks; one (1), 15-passenger van; one (1) cutaway van with utility body; and two (2) full size sport utility vehicles;

- 7) Medical Examiner is requesting \$100,000 in expenditure authority to procure three (3) heavy cargo vans;
- 8) Parks, Recreation and Open Spaces is requesting \$2,547,000 in expenditure authority to procure 14, ½ ton 4x4 pickup trucks; 12, ½ ton 4x2 pickup trucks; 33, ¾ ton 4x2 pickup trucks; four (4), ¾ ton 4x4 pickup trucks; two (2) compact 4x2 pickup trucks; three (3) compact 4x4 pickup trucks; five (5) hybrid sedans; two (2), 4x2 sport utility vehicles; two (2), 4x4 sport utility vehicles; 10 heavy cargo vans; one (1) mini cargo van; and one (1), one-ton 4x2 pickup truck;
- 9) Police is requesting \$10,000,000 in expenditure authority to procure 252 police pursuit sedans; 10 full-size sedans; 136 mid-size sedans; four (4) compact sedans; two (2), 15-passenger vans; 15, ½ ton 4x4 pickup trucks; one (1), ¾ ton 4x4 pickup truck; five (5), one-ton 4x4 pickup trucks; three (3) heavy cargo vans; 28 police package all-wheel drive sport utility vehicles; and two (2) sport utility vehicles;
- 10) Regulatory and Economic Resources is requesting \$1,900,000 in expenditure authority to procure three (3), ½ ton 4x4 pickup trucks; one (1) mini cargo van; 51 compact 4x2 pickup trucks; 23 hybrid sedans; one (1), ¾ ton 4x2 pickup truck; three (3) compact 4x4 pickup trucks; four (4) sport utility vehicles; and three (3), ¾ ton 4x4 pickup trucks;
- 11) Vizcaya Museum and Gardens is requesting \$30,000 in expenditure authority to procure one (1) compact 4x2 pickup truck; and
- 12) Water and Sewer is requesting \$3,901,000 in expenditure authority to procure five (5) minivans; 15 heavy cargo vans; two (2) compact 4x4 pickup trucks; 51 compact 4x2 pickup trucks; 29, ½ ton 4x2 pickup trucks; 10, ½ ton 4x4 pickup trucks; 16, ¾ ton 4x2 pickup trucks; seven (7), ¾ ton cab and chassis with utility body trucks; and four (4), ¾ ton 4x4 pickup trucks.

Scope

The impact of this item is countywide in nature.

Fiscal Impact/Funding Source

The fiscal impact for the term, which expires on September 30, 2017, is \$27,128,000. The requested allocation under this contract is based on identified purchases and projected future needs.

In FY 2016-17, the Adopted Budget and Multi Year Capital Plan assumes a procedural change regarding the purchasing of light and heavy fleet for all County departments. In prior fiscal years, departments contributed on an annual basis to a Fleet Replacement Trust Fund towards the replacement of their fleet upon its useful life. The Internal Services Department, in conjunction with the Office of Management and Budget and Finance, will now be working with each department to coordinate bulk purchases while utilizing the most appropriate contract and financing instrument.

Delegated Authority

The County Mayor or County Mayor's designee will have the authority to exercise all provisions of the contract pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38.

Awarded Vendors

There are 33 awarded vendors, of which the County is recommending award to the 16 that have completed the vendor registration process. See attached table. Outreach to additional awarded vendors is ongoing.

Due Diligence

Pursuant to Resolution No. R-187-12, due diligence was conducted in accordance with the Internal Services Department's Procurement Guidelines to determine vendor responsibility, including verifying corporate status and that there are no performance or compliance issues through various vendor responsibility lists and a keyword internet search. The lists that were referenced included convicted vendors, debarred vendors, delinquent contractors, suspended vendors and federal excluded parties. There were no adverse findings relating to vendor responsibility.
