RESOLUTION EXPRESSING SUPPORT FOR THE MIAMI RIVER COMMISSION'S REQUEST FOR FUNDING FROM THE FLORIDA LEGISLATURE; URGING THE FLORIDA LEGISLATURE TO PROVIDE FUNDING FOR THE MIAMI RIVER COMMISSION

WHEREAS, in 1998, in an effort to improve the 5.5-mile Miami River and its surroundings, including the 69-square-mile water basin that includes much of the City of Miami and a portion of Miami-Dade County, the Florida Legislature created the Miami River Commission; and

WHEREAS, section 163.06(1)(a), Florida Statutes, established the Miami River Commission as "the official coordinating clearinghouse for all public policy and projects related to the Miami River"; and

WHEREAS, the Miami River Improvement Act, section 163.065(3), Florida Statutes, states that all "state and regional agencies shall provide all available assistance to the Miami River Commission in the conduct of its activities"; and

WHEREAS, the Miami River Commission utilizes funding from various sources to engage in a variety of activities that directly improve the Miami River; and

WHEREAS, the City of Miami, Miami-Dade County, the Miami Downtown Development Authority and the private sector provide 45 percent of the Miami River Commission's funding; and

WHEREAS, the remainder of the Miami River Commission's total annual budget is provided by the State of Florida; and

WHEREAS, the Florida Legislature has previously approved the Miami River Commission's request for funding for Fiscal Year (FY) 2014-15, FY 2015-16 and FY 2016-17; and

WHEREAS, the Miami River Commission has again requested funding from the Florida Legislature during the 2017 Legislative Session; and

WHEREAS, this funding will be used to support efforts to decontaminate the Miami River, remove illegal dumping and invasive plant species, provide landscaping maintenance within state-owned submerged lands, deliver materials to hundreds of volunteers at beautification events and keep the public and private sectors informed about the Miami River Commission's activities; and

WHEREAS, this funding is critical to continue improving the Miami River's environment and aesthetics, which will then attract more new job-generating businesses and residential developments to open along the Miami River,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Supports the Miami River Commission's request for funding from the Florida Legislature.

Section 2. Urges the Governor and Florida Legislature to provide funding for the Miami River Commission.

<u>Section 3</u>. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Governor, Senate President, House Speaker, Senator Rene Garcia, Representative Jose Felix Diaz, the Chair and remaining Members of the Miami-Dade State Legislative Delegation, and the Chair and members of the Miami River Commission.

Section 4. Directs the County's state lobbyists to advocate for the funding indicated in Sections 1 and 2 above, and authorizes and directs the Office of Intergovernmental Affairs to amend the 2017 State Legislative Package to include this item.

The Prime Sponsor of the foregoing resolution is Commissioner Bruno A. Barreiro.
