RESOLUTION URGING PRESIDENT DONALD TRUMP AND THE UNITED STATES CONGRESS TO SUPPORT AND ENACT COMPREHENSIVE IMMIGRATION REFORM DURING THE 115TH CONGRESS

WHEREAS, the United States has long prided itself as being a nation of immigrants; and WHEREAS, currently, there are an estimated 11.2 million undocumented immigrants living in the United States; and

WHEREAS, a majority of Americans favor comprehensive immigration reform including, in some form, a pathway to citizenship for undocumented immigrants currently living and working in the United States who have not committed a serious crime; and

WHEREAS, over the last decade, a number of congressional efforts to pass comprehensive immigration reform bills have come close to passing but have fallen short; and

WHEREAS, bipartisan comprehensive immigration reform bills have passed in the U.S. Senate in 2006 and 2013, but both bills ultimately died during their respective congressional sessions; and

WHEREAS, advocates that support comprehensive immigration reform include a broad range of groups across a wide spectrum of political views, including religious leaders, business executives, and civil liberty groups alike; and

WHEREAS, on December 18, 2012, this Board adopted Resolution No. R-1084-12, which urged the President and the U.S. Congress to support and enact comprehensive immigration reform during the 113th Congress; and

WHEREAS, on March 5, 2013, this Board also adopted Resolution No. R-184-13, which expanded the scope of issues and the elements of reform which this Board supported; and

WHEREAS, Resolution No. R-184-13 adopted the immigration reform platform espoused by the Partnership for a New American Economy, a bipartisan group of mayors, elected officials, and business leaders from all sectors of the economy; and

WHEREAS, this Board would also like to indicate its support for immigration reform proposals that facilitate family reunification and end the separation of law-abiding families; and

WHEREAS, this Board is especially supportive of immigration reform measures which provide a pathway to citizenship for law-abiding undocumented immigrants as well as for "Dreamers," a group of nearly two million immigrants who were brought into the country illegally as children,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Urges President Donald Trump and the United States Congress to support and enact comprehensive immigration reform during the 115th Congress which will provide a pathway for undocumented, but law-abiding immigrants already in the United States to gain citizenship.

Section 2. Supports immigration reform proposals that facilitate family reunification, as well as ensuring a pathway to citizenship for Dreamers.

<u>Section 3.</u> Directs the Clerk of the Board to transmit a certified copy of this resolution to President Donald Trump, the Members of the Florida Congressional Delegation, and the Secretary of the U.S. Department of Homeland Security.

Section 4. Directs the County's federal lobbyists to advocate for the action set forth in Sections 1 and 2 above, and authorizes and directs the Office of Intergovernmental Affairs to include this item in the 2017 Federal Legislative Package.
