#### RECOMMENDATION

The Spay/Neuter Miami Foundation (SNMF) was created to promote and raise funds towards the work and mission of the Miami-Dade County Animal Services Department (ASD). Recently, the SNMF did not have active board members due to the passing of one board member, Dee Chess, in July 2016, and the expiration of the other board members' terms in October 2016. In April 2017, two new board members were appointed by the Mayor in order to reengage the entity in ASD's lifesaving work, leaving an additional five positions to be appointed by the Board of County Commissioners (the Board).

It is recommended that the Board now appoint Peter Celnicker due to his commitment to the community, dedication to the homeless pet population, and willingness to serve on the SNMF Board. Attached, please find the resume of Peter Celnicker.

#### BACKGROUND

On March 3, 2009, the Board adopted Resolution No. R-219-09, authorizing the County Mayor or County Mayor's designee to facilitate the creation of the SNMF, and on October 21, 2009, SNMF was created. The purpose of SNMF and the responsibilities of the members would be to fundraise in support of community spay-and-neuter services and ASD. In 2014, the SNMF, with Board approval, decided to reduce the overall membership in order to better facilitate meetings and achieve quorum. This allowed for a total of seven members, with five appointed by the Board and two appointed by the Mayor.

### RESOLUTION NO.

RESOLUTION APPROVING THE APPOINTMENT OF PETER CELNICKER TO THE BOARD OF DIRECTORS OF THE SPAY/NEUTER MIAMI FOUNDATION, INC.

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, on May 6, 2014, the Board of County Commissioners adopted Resolution No. R-433-14 to amend the Articles of Incorporation of the Spay/Neuter Miami Foundation, Inc. (the "Foundation") to reduce the membership in the Foundation's Board of Directors from fifteen (15) members to seven (7); and

WHEREAS, the Articles of Incorporation direct that five (5) Directors be appointed by the Board and two (2) Directors be appointed by the Mayor; and

WHEREAS, each Director shall be appointed for a two-year term, except that the term of each Director appointed by the Mayor shall end concurrently with last day of the Mayor's term; a position shall be deemed vacant at the expiration of a term unless the member has been reappointed for another term in accordance with the article; and each member shall be permitted to serve two (2) full consecutive terms at most but may be reappointed after ceasing to be a member for one (1) year,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board hereby approves the appointment of Peter Celnicker to the Spay/Neuter Miami Foundation, Inc. Board of Directors.
