RESOLUTION NO.

RESOLUTION CODESIGNATING THAT PORTION OF N.W. 104TH STREET BETWEEN N.W. 11TH AVENUE AND N.W. 12TH AVENUE AS "KING CARTER STREET"

WHEREAS, in February 2016, King Carter was a six-year-old first-grader who attended Van E. Blanton Elementary School and played football for the Liberty City Warriors; and

WHEREAS, King loved watching the Power Rangers and Teenage Mutant Ninja Turtles on television, and he wanted to be a police officer when he grew up; and

WHEREAS, as reported in The Miami Herald, King's great-aunt described him as having a "big personality," noting that "[i]f you spent time with him, you knew you had been around someone great," and "he would leave a huge impression"; and

WHEREAS, on February 20, 2016, King was killed while walking to buy candy at a nearby store, caught in the cross-fire of a teenager who had intended to shoot someone else; and

WHEREAS, King's family has rallied against gun violence since his death, giving back to the community through volunteering at local schools and churches; and

WHEREAS, to mark the one-year anniversary of King's death, friends and family members came to together to honor and remember King at the N.W. 54th Street gas station that King used to frequent and at which a wall mural of him wearing his football jersey has been displayed; and

WHEREAS, to mark the anniversary of his death, King's football teammates also wore yellow-and-black jerseys bearing King's name and donned gold crowns atop their heads in his memory; and

WHEREAS, King's teammates also marched to Charles Hadley Park carrying a banner displaying photos of King and bearing the words, "We Love You King Carter"; and

WHEREAS, at the park, an array of balloons were used to spell out King's name in the center of the football field; and

WHEREAS, as reported in The Miami Herald, once at the park, the marchers released the balloons to the sky to honor King, prompted by a proclamation that "[w]e release [the balloons] in memory of King Carter and we thank you for allowing him the time to be with us [that] you did"; and

WHEREAS, the portion of N.W. 104th Street between N.W. 11th Avenue and N.W. 12th Avenue is a County maintained road located in unincorporated Miami-Dade County; and

WHEREAS, Rule 9.02 of the Board's Rules of Procedure provides that resolutions regarding proposed naming, renaming or codesignation of Miami-Dade County roads, facilities or properties shall be sponsored by the district commissioner where the road, facility or property is located; and

WHEREAS, this codesignation is located in County Commission District 2; and

WHEREAS, to honor the memory of King Carter who died much too young, this Board wishes to codesignate the portion of N.W. 104th Street between N.W. 11th Avenue and N.W. 12th Avenue as "King Carter Street,"

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Incorporates and adopts the foregoing whereas clauses as part of this resolution.

Section 2. Having considered this matter at a public hearing, codesignates the portion of N.W. 104th Street between N.W. 11th Avenue and N.W. 12th Avenue as "King Carter Street."

Section 3. Directs the Clerk of the Board to transmit a certified copy of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade County Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Jean Monestime. It was offered by Commissioner , who moved its adoption. The motion was seconded by Commissioner and upon being put to a vote, the vote was
