Recommendation

It is recommended that the Board of County Commissioners (Board) approve the attached resolution authorizing the County Mayor or County Mayor's designee to conduct Police Product Expositions on an annual basis, or as necessary, which could be coordinated by the Miami-Dade Public Safety Training Institute.

Scope

The Police Product Expositions will be made available to agencies as appropriate.

Fiscal Impact/Funding Source

There is no fiscal impact to the County as the Expositions will be conducted during normal working hours.

Track Record/Monitor

Michael Dieppa, Major, Miami-Dade Public Safety Training Institute of the Miami-Dade Police Department (MDPD), will manage the Expositions to ensure that the events are conducted in accordance with the policies and procedures of Miami-Dade County and the MDPD.

Background

Each year new law enforcement products and technologies are developed in response to emerging trends occurring across the nation. These new products have the potential to provide law enforcement agencies with the ability to improve operational effectiveness and efficiency and more importantly enhance service to the community and officer safety. The primary purpose of the Expositions are for information and education. The Expositions are extremely helpful to the MDPD and other area law enforcement agencies for several other reasons including: 1) providing an opportunity for officers to view a wide variety of the latest products and technologies directly; 2) providing a way to connect with surrounding agencies and discuss trends specific to that agency; and 3) having Expositions available locally makes it cost effective (i.e., precludes airfare, lodging, and per diem expenses for out of area travel). Vendors would be required to authorize a hold harmless document for participation. There would not be any purchases allowed at the Expositions.
