Request for Additional Expenditure Authority to Prequalification Pool No. 2121-3/13-

2, Fire Rescue Replacement Equipment

This item was amended at the October 11, 2017 Public Safety and Health Committee meeting to remove the references to the current equipment reaching the end of its useful life and its compliance with the National Fire Protection Association standards.

Recommendation

It is recommended that the Board of County Commissioners authorize additional expenditure authority for *Prequalification Pool No. 2121-2/13-2, Fire Rescue Replacement Equipment*, for the Miami-Dade Fire Rescue Department. The Department is requesting \$4,982,000 in additional expenditure authority in order to purchase replacement life safety equipment for Miami-Dade County firefighters.

The County established this pool on February 20, 2007 for a five-year term with two, one-year option to renew terms. The Board approved a five-year extension of the pool through Resolution No. R-979-13 and the pool is currently in the third year of the five-year extension. County departments use this pool to purchase fire rescue replacement equipment including chemical booster hoses, fire hoses, fittings, nozzles, test gauges, overhaul and entry tools, extrication and rescue equipment, electric smoke detectors, self-contained breathing apparatus equipment, and related equipment and supplies.

Fire Rescue is requesting additional expenditure authority to purchase replacement self-contained breathing apparatus equipment compliant with the latest National Fire Protection Association standards. In order to ensure firefighter safety and to avoid unnecessary injuries, it is recommended that additional expenditure authority be approved to properly outfit approximately 2,000 sworn firefighters with replacement equipment.

<u>Scope</u>

The impact of this item is countywide in nature.

Fiscal Impact/Funding Source

The current contract term expires on February 28, 2019 and has a cumulative allocation of \$18,287,000. If this request is approved, the contract will have a modified cumulative value of \$23,309,000. The requested increase in expenditure authority is based on the projected cost of the replacement equipment.

Track Record/Monitor

Celeste Walker of the Internal Services Department is the Procurement Contracting Manager.

Delegated Authority

There is no additional delegation of authority sought in this item as the authority to solicit pricing and award contracts up to an aggregate amount of the allocation authorized by the Board, exercise all provisions of the solicitation documents and any resulting contracts pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38, and add vendors to the pool at any time, subject to ratification by the Board on a bi-annual basis, was granted when the pool was established under Resolution No. R.179-07.

Prequalified Vendors

There are currently 29 prequalified vendors, of which two have a Miami-Dade County address. See Attachment 1, Prequalified Vendors. Staff conducted market research to determine if additional local firms were available that manufacture or distribute the requested equipment. However, additional local firms could not be located. The Internal Services Department will continue to advertise the prequalification pool on its website so additional local firms may be prequalified and added to the pool.

Due Diligence

Pursuant to Resolution No. R-187-12, due diligence was conducted in accordance with the Internal Services Department's Procurement Guidelines to determine contractor responsibility, including verifying corporate status and review of performance and compliance issues. The lists referenced include convicted vendors, debarred vendors, delinquent contractors, suspended vendors, and federal excluded parties. There were no adverse findings relating to contractor responsibility.

Applicable Ordinances and Contract Measures

- The User Access Program provision applies and the two percent where permitted by funding source.
- The Small Business Enterprise Bid Preference and Local Preference ordinances will be applied at the time of spot market competition where permitted by funding source.
- The Living Wage Ordinance does not apply.
