CODESIGNATION OF SW 22ND STREET (CORAL WAY) FROM SR 933/SW 12TH AVENUE TO SW 13TH AVENUE AS "LUIS FERNANDO BRANDE STREET"

WHEREAS, during the 2017 session, the Florida Legislature passed, and the Governor approved, Senate Bill 368 which codesignated SW 22nd Street (Coral Way) from SR 933/SW 12th Avenue to SW 13th Avenue as "Luis Fernando Brande Street"; and

WHEREAS, on July 27, 2017, the City of Miami Commission passed Resolution No. R-17-0363 supporting the Florida Legislature's codesignation of SW 22nd Street (Coral Way) from SR 933/SW 12th Avenue to SW 13th Avenue as "Luis Fernando Brande Street"; and

WHEREAS, Resolution No. R-17-0363 is attached and incorporated by reference; and

WHEREAS, Mr. Brande was born in Havana, Cuba on May 30, 1954 and immigrated to Miami in November 1961; and

WHEREAS, Mr. Brande played baseball for Miami-Dade Community College and for the University of Miami where he received a bachelor's degree in Education and was a member of Kappa Delta Pi Educational Honors Society; and

WHEREAS, after many years of mentoring, teaching, and coaching baseball, Mr. Brande was diagnosed with Bulbar Onset ALS (Lou Gehrig's disease) in October 2012; and

WHEREAS, Mr. Brande passed away on December 15, 2015; and

WHEREAS, section 334.071, Florida Statutes, provides that the installation of state road designation signs shall be contingent on the applicable county or city commission passing a resolution in support of the particular honorary road designation; and

WHEREAS, before the Florida Department of Transportation will install signs reflecting the "Luis Fernando Brande Street" road codesignation, Miami-Dade County is required to pass a resolution in support of this road designation; and

WHEREAS, this Board would like to honor Mr. Brande by approving the state road codesignation of SW 22nd Street (Coral Way) from SR 933/SW 12th Avenue to SW 13th Avenue as "Luis Fernando Brande Street"; and

WHEREAS, that portion of SW 22nd Street (Coral Way) from SR 933/SW 12th Avenue to SW 13th Avenue is a state road located within the City of Miami and within County Commission District 5,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the state road codesignation of SW 22nd Street (Coral Way) from SR 933/SW 12th Avenue to SW 13th Avenue as "Luis Fernando Brande Street".

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Secretary of the Florida Department of Transportation, the Mayor and City Commission of the City of Miami, the United States Postal Service, the Traffic Signals and Signs Division of the Transportation and Public Works Department, the Development Services Division of the Regulatory and Economic Resources Department, the City of Miami Police Department and the City of Miami Fire Department.

The Prime Sponsor of the foregoing resolution is Commissioner Bruno A. Barreiro.

It was offered by Commissioner , who moved its adoption. The motion was seconded by Commissioner and upon being put to a vote, the vote was as follows:

A RESOLUTION OF THE MIAMI CITY COMMISSION DECLARING NO OBJECTION AND SUPPORTING THE CO-DESIGNATION BY THE FLORIDA LEGISLATURE, PURSUANT TO SENATE BILL 368, DESIGNATING THAT PORTION WITHIN THE CITY OF MIAMI LIMITS OF SOUTHWEST 22ND STREET, BETWEEN S.R. 933/SOUTHWEST 12TH AVENUE AND SOUTHWEST 13TH AVENUE, MIAMI, FLORIDA, IN MIAMI-DADE COUNTY AS "LUIS FERNANDO BRANDE STREET;" FURTHER DIRECTING THE CITY CLERK TO TRANSMIT A COPY OF THIS RESOLUTION TO THE FLORIDA DEPARTMENT OF TRANSPORTATION, DISTRICT SIX, FOR SIGN INSTALLATION WITHIN THE NEWLY DESIGNATED ROADWAY.

WHEREAS, the 2017 Florida State Legislature, pursuant to Senate Bill 368, requested a honorary designation of a road located within the City of Miami ("City") for "Luis Fernando Brande Street;" and

WHEREAS, the Miami City Commission has no objection and supports the proposed street co-designation of that portion within the City limits of Southwest 22nd Street between S.R. 933/Southwest 12th Avenue and Southwest 13th Avenue, Miami, Florida in Miami-Dade County as "Luis Fernando Brande Street;"

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF MIAMI, FLORIDA:

Section 1. The recitals and findings contained in the Preamble of this Resolution are adopted by reference and incorporated as if fully set forth in this Section.

Section 2. The Miami City Commission declares no objection and supports the above-referenced co-designation by the Florida Legislature, pursuant to Senate Bill 368, designating that portion within the City limits of Southwest 22nd Street between S.R. 933/Southwest 12th Avenue and Southwest 13th Avenue, Miami, Florida, in Miami-Dade County as "Luis Fernando Brande Street."

Section 3. The City Clerk is directed to transmit a copy of this Resolution to the Florida Department of Transportation, District Six, for sign installation within the newly co-designated roadway.

Section 4. This Resolution shall become effective immediately upon its adoption and signature of the Mayor.¹



¹ If the Mayor does not sign this Resolution, it shall become effective at the end of ten calendar days from the date it was passed and adopted. If the Mayor vetoes this Resolution, it shall become effective immediately upon override of the veto by the City Commission.
