	RESOLUTION APPROVING THE CODESIGNATION OF NW 9TH STRUAVENUE TO NW 42ND AVENUE

WHEREAS, the Miami City Commission passed Resolution R-17-0236 on May 11, 2017, which codesignated that portion of NW 9th Street from NW 40th Avenue to NW 42nd Avenue as "Major Jorge Sanchez Street" in memory of City of Miami Police Major Jorge Sanchez; and

**WHEREAS**, a copy of Resolution R-17-0236 is attached hereto and incorporated herein by reference; and

WHEREAS, Major Jorge Sanchez began his career with the City of Miami Police Department in 1995, working in various specialized units over his 21 year career; and

WHEREAS, Major Sanchez worked as a member of the City of Miami Police Department's Motorcycle Unit for over 10 years until he was tragically killed in an on-duty motorcycle accident on November 1, 2016; and

**WHEREAS**, Major Sanchez is survived by his mother Maria, his former wife Regia, his fiancée Evelyn, and his three children Elizabeth, Jorge, and Eric Sanchez; and

WHEREAS, that portion of NW 9th Street from NW 40th Avenue to NW 42nd Avenue is a city road located in the City of Miami; and

WHEREAS, this codesignation is located in County Commission District 6; and

WHEREAS, the City of Miami would like for the County to install signage indicating this codesignation on County street signs and traffic signal mast arms; and



WHEREAS, this Board would also like to honor City of Miami Police Major Jorge Sanchez by approving the City of Miami codesignation of NW 9th Street from NW 40th Avenue to NW 42nd Avenue as "Major Jorge Sanchez Street",

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Miami codesignation of NW 9th Street from NW 40th Avenue to NW 42nd Avenue as "Major Jorge Sanchez Street".

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Mayor and City Commission of the City of Miami, the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resources Department, the City of Miami Police Department, and the City of Miami Fire-Rescue Department.

A RESOLUTION OF THE MIAMI CITY COMMISSION CODESIGNATING NORTHWEST 9TH STREET FROM NORTHWEST 40th AVENUE TO NORTHWEST 42ND AVENUE, MIAMI, FLORIDA AS "MAJOR JORGE SANCHEZ STREET"; FURTHER DIRECTING THE CITY CLERK TO TRANSMIT A COPY OF THIS RESOLUTION TO THE HEREIN DESIGNATED OFFICES.

WHEREAS, Major Jorge Sanchez began his career with the City of Miami Police Department ("MPD") in January 1995; and

WHEREAS, Major Jorge Sanchez worked many specialized units, including but not limited to the Gang Unit, the Missing Persons Unit, the Allapattah Problem Solving Team, the Traffic Enforcement Unit, and the Investigations Division; and

WHEREAS, Major Jorge Sanchez often conveyed to others how proud he was to be a Motorcycle Officer and how he enjoyed working with the other members of the Motorcycle Unit in which he was a part of for the last ten (10) years of his career; and

WHEREAS, Major Jorge Sanchez was tragically killed in an on duty motorcycle accident on November 1, 2016; and

WHEREAS, Major Jorge Sanchez is survived by his mother Maria, his former wife Regla, his fiancée Evelyn, and his three children Elizabeth, Jorge, and Officer Eric Sanchez, who followed in his father's footsteps and became a City of Miami Police Officer;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF MIAMI, FLORIDA:

- Section 1. The recitals and findings contained in the Preamble to this Resolution are adopted by reference and incorporated as if fully set forth in this section.
- Section 2. Northwest 9th Street from Northwest 40th Avenue to Northwest 42nd Avenue, Miami, Florida, is codesignated as "Major Jorge Sanchez Street."
- Section 3. The City Clerk is directed to transmit a copy of this Resolution to the Departments of Police, Fire-Rescue, Solid Waste, the Miami-Dade County Department of Transportation and Public Works, and the United States Postal Service.

Section 4. This Resolution shall become effective immediately upon its adoption and signature of the Mayor.<sup>1</sup>

<sup>&</sup>lt;sup>1</sup> If the Mayor does not sign this Resolution, it shall become effective at the end of ten (10) calendar days from the date it was passed and adopted. If the Mayor vetoes this Resolution, it shall become effective immediately upon override of the veto by the City Commission.
