Subject: Contract Award Recommendation in the Amount of \$322,974.79 to Highway Striping, Inc., for the Project Entitled People's Transportation Plan Pavement Markings Installation Project; and Authorizing the Use of Charter County Transportation Surtax Funds for Such Purposes

Recommendation

The attached Contract Award Recommendation for the Project Entitled People's Transportation Plan (PTP) project entitled *Pavement Markings Installation Project* (Project MCC 7040 Plan - CICC 7040-0/07), Request for Price Quotation (RPQ) No. 20170262) in the amount of \$322,974.79 to Highway Striping, Inc., was prepared by the Department of Transportation and Public Works (DTPW) and is recommended for approval by the Board of County Commissioners (Board).

This Contract Award Recommendation is placed for Committee review pursuant to Miami-Dade County Code Section 29-124(f). This Contract Award Recommendation may only be considered by the Board if the Citizens' Independent Transportation Trust (CITT) has forwarded a recommendation to the Board prior to the date scheduled for Board consideration or forty-five (45) days have elapsed since the filing with the Clerk of the Board of this Contract Award Recommendation. If the CITT has not forwarded a recommendation and forty-five (45) days have not elapsed since the filing of this Contract Award Recommendation, I will request a withdrawal of this item.

Scope

The locations of work to be performed under the terms of this Contract are tentatively listed as:

1. SW 136 Street from SW 194 Avenue to SW 199 Avenue located in District 9, represented by Commissioner Dennis C. Moss,
2. NW 17 Avenue from NW 167 Street to Miami Gardens located in District 1, represented by Commissioner Barbara J. Jordan,
3. SW 62 Street from SW 102 Avenue to SW 107 Avenue located in District 10, represented by Commissioner Javier D. Souto,
4. SW 217 Avenue from SW 232 Street to SW 392 Street located in District 9, represented by Commissioner Dennis C. Moss,
5. NW 47 Avenue from NW 183 Street to NW 167 Street located in District 1, represented by Commissioner Barbara J. Jordan,
6. NW 17 Avenue from NW 54 Street to NW 71 Street located in District 3, represented by Vice Chairwoman Audrey M. Edmonson,

Fiscal Impact/Funding Source

The fiscal impact of this contract award will be approximately \$322,974.79. The base contract amount is \$259,798.40, exclusive of contingency and dedicated allowance amounts. There is no additional fiscal impact to operations or maintenance. The proposed improvements qualify under the allowable work categories included in the PTP Neighborhood Improvements Section. The Project is included in the FY 2017-18 Adopted Capital Budget as SAFETY IMPROVEMENTS – COUNTYWIDE (2000000541) / S77055 - PEOPLE'S TRANSPORTATION PLAN PAVEMENT MARKINGS & funded by Charter County Transit System Surtax funds.

Delegation of Authority

No additional authority is being requested within the body of this Contract.

Track Record/Monitor

Following DTPW's standard operating procedures, after award of this Contract, a pre-construction meeting will be scheduled. The project will be assigned to Joaquin Rabassa, P.E., Construction Coordinator, Chief, DTPW for the day-to-day responsibilities.


Background

As part of the PTP Neighborhood Improvements initiative, DTPW continues to take advantage of various contracting mechanisms such as the Miscellaneous Construction Contracting (MCC) process available under the MCC 7040 Plan. Through this process, DTPW forwards an RPQ, by way of facsimile transmission, to a pool of firms that have registered with Internal Services Department for the respective trade. Additionally, DTPW advertises the project in the *Daily Business Review* and all solicitations are available on-line through the County portal under the "Procurement Solicitations" link. The project's award evaluation is based upon the bid submitted by the lowest responsive, responsible bidder for the project.

DTPW forwarded RPQ No. 20170262, utilizing the MCC 7040 Plan, to a list of 61 pre-qualified firms. On November 29, 2017, Highway Striping, Inc. proffered the lowest responsive and responsible base bid of \$259,798.40, 17.48 percent below the County's cost estimate. The second lowest bidder, P & J Striping, Inc., proffered a base bid of \$314,590.72, 0.08 percent below the County's cost estimate. The third lowest bidder, Dremcon Construction Corp., proffered a base bid of \$437,881.45, 38.81 percent over the County's cost estimate.

Based on the result of the solicitation, DTPW issued a recommendation for award on December 6, 2017 for RPQ No. 20170262 to Highway Striping, Inc., with the stipulation that approval for this project must be obtained from the CITT and the Board.




