Subject: Resolution Approving the Waiver of Plat of 6705 Q Holdings, LLC

Recommendation

The following waiver of plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This waiver of plat for 6705 Q Holdings, LLC is bounded on the north approximately 300 feet south of SW 66 Street, on the east approximately 300 feet west of SW 93 Avenue, on the south approximately 160 feet north of SW 68 Street, and on the west by SW 94 Avenue.

The Miami-Dade County Plat Committee recommends approval of this waiver of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Scope

This waiver of plat is located in Commission District 10, which is represented by Senator Javier D. Souto.

Fiscal Impact/Funding Source

There is no fiscal impact to Miami-Dade County with the approval of this waiver of plat as all improvements are in place.

The Development Services Division of the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.

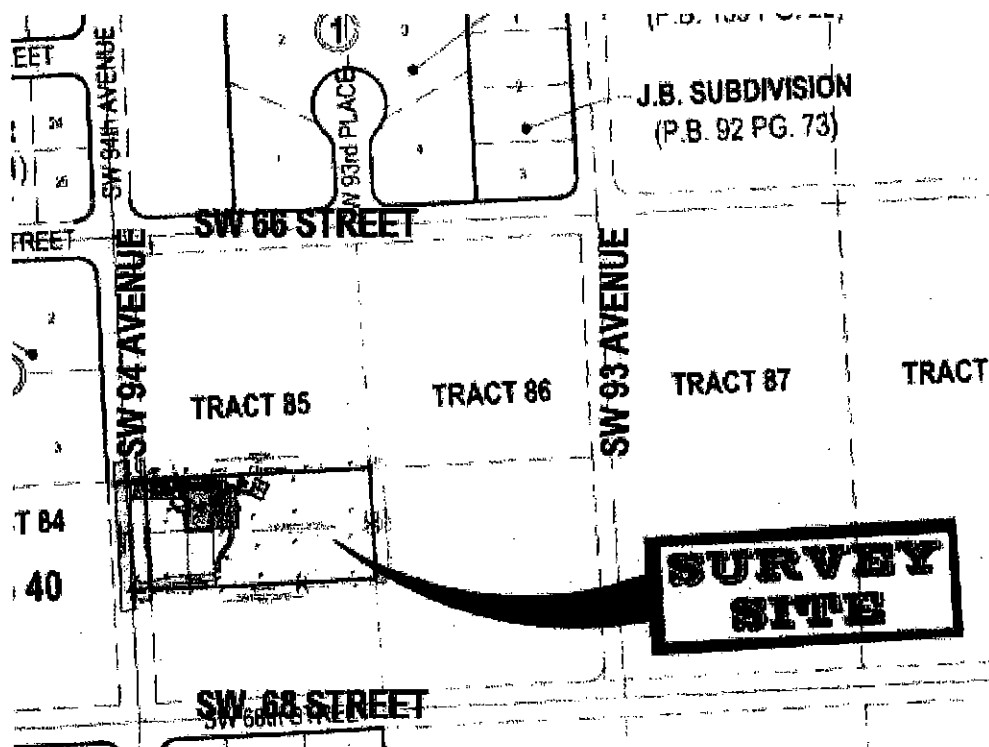

RESOLUTION APPROVING THE WAIVER OF PLAT OF 6705 Q HOLDINGS, LLC, D-24035, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 28, TOWNSHIP 54 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH APPROXIMATELY 300 FEET SOUTH OF SW 66 STREET, ON THE EAST APPROXIMATELY 300 FEET WEST OF SW 93 AVENUE, ON THE SOUTH APPROXIMATELY 160 FEET NORTH OF SW 68 STREET, AND ON THE WEST BY SW 94 AVENUE)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, 6705 Q Holdings, LLC, a Florida limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of Tract "85" of "Subdivision of Section 20 and West ½ of Section 28 for the Dade County Development Company", according to the plat thereof, as recorded in Plat Book 3, at Page 169, of the Public Records of Miami-Dade County, Florida, lying and being in the Southwest 1/4 of Section 28, Township 54 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any

zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.
