Resolution Approving the Plat of Dice Point

<u>Recommendation</u>

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Dice Point is bounded on the north by SW 98 Street, on the east approximately 440 feet west of SW 77 Avenue, on the south by SW 99 Street, and on the west approximately 105 feet east of SW 77 Place.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Scope

This plat is located in Commission District 7, which is represented by Commissioner Xavier L. Suarez.

Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the County would be approximately \$50 annually for new sidewalk construction adjacent to the project. These costs would be covered by the Department of Transportation and Public Works' annual General Fund allocation.

Track Record/Monitor

The Development Services Division of the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.



RESOLUTION APPROVING THE PLAT OF DICE POINT, LOCATED IN THE SOUTHEAST 1/4 OF SECTION 3, TOWNSHIP 55 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY SW 98 STREET, ON THE EAST APPROXIMATELY 440 FEET WEST OF SW 77 AVENUE, ON THE SOUTH BY SW 99 STREET, AND ON THE WEST APPROXIMATELY 105 FEET EAST OF SW 77 PLACE)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is in incorporated herein by reference; and

WHEREAS, Saika Partners, LLC, a Florida limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as Dice Point, the same being a replat of Lots 13, 14, 25, and 26, Block 1, of "Hinson's Addition to Kendal", according to the plat thereof, as recorded in Plat Book 5, at Page 1, of the Public Records of Miami-Dade County, Florida, lying and being in the Southeast 1/4 of Section 3, Township 55 South, Range 40 East, Miami-Dade County, Florida, and that portion of the 12 foot alley lying between said Lots 13, 14, 25, and 26, closed, vacated, and abandoned per Resolution No. R-440-02, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any

zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.
