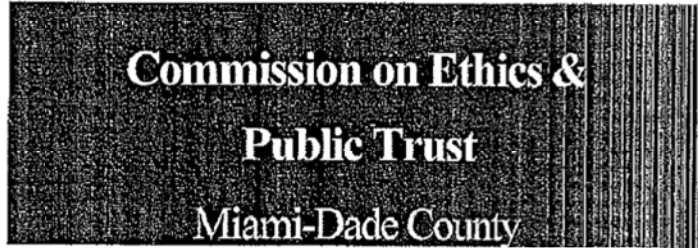

Pursuant to the provisions of Resolution R-1017-10, the attached Lobbyist Conflict Waiver Requests, received from Ronald L. Book, Nelson Diaz and Sean Pittman, are forwarded to the Board for its consideration, together with the Commission on Ethics staff report and recommendation.

It is the recommendation of Ethics Commission staff that the waivers be denied. The basis for this recommendation of denial is that the conflict presented involves three lobbyists on the County's lobbying team taking a position on behalf of other clients that is directly at odds with the County's longstanding and principled opposition to any State legislation that would undermine the County's Home Rule powers.

Background:

On March 2, 2018, Ronald L. Book, Esq. (Book), of the law firm of Ronald L. Book, P.A. wrote to request a conflict waiver pursuant to County Resolution R-632-10.¹ In the letter, attached as Exhibit A, Book indicates that he has represented the pet industry for many years. The pet industry favors State pre-emption of local government in regulating the sale of puppies and kittens. Book stressed that he has worked to craft a compromise creating reasonable regulations to avoid pre-emption. Book is overseeing a "lobbyist team" that is working in the interests of the pet industry specifically opposing a ban on the sale of puppies by local governments. The waiver was requested, although Book is not assigned by the County to lobby on behalf of the County on any issue involving pets.

Book currently serves as one of the County's Government Lobbyists.

The Miami-Dade Commission on Ethics & Public Trust (COE) has been requested to conduct a review of the Book Conflict Waiver request.

Investigation:

The COE staff conducted a fact-finding inquiry which included the following actions:

- Review Book's conflict waiver request letter dated 3/2/2018.

- Review Diaz and Pittman waiver requests.
- Discussion with Assistant County Attorney Jess McCarty.
- Discussion with Attorney Ronald L. Book.

The COE staff determined the following:

Book has represented the pet industry's interests for the last five or six years.

During this legislative session, Book has supervised a "team of lobbyists" supporting legislation opposing a ban on the sale of puppies by local governments. According to Book, no such ban presently exists in Miami-Dade County. Passage of such legislation by the State would effectively pre-empt the County from enacting such a ban in the future.

The County has consistently opposed legislation that would pre-empt local government from taking action on or regulating activity within its borders.

Book is a "prime" contract lobbyist. Two other lobbyists, Sean Pittman and Nelson Diaz are sub-contractors to Book and are part of the "lobbyist team."

Passage of House Bill 7087/Senate Bill 740 providing for a ban against the sale of domestic animals, would have violated a longstanding and guiding principle of the County's legislative lobbying efforts at the State level, namely, that the County opposes any effort to pre-empt local authority that would undermine County Home Rule.

The language in HB7087/SB740 containing the objectionable provision was not included in the legislation when passed by the Legislature. Since the legislative session ended on March 11, 2018, there is no possibility that this legislation could be enacted during this legislative cycle.

According to Book, since the legislative session is over there is no legislative or executive branch lobbying going on regarding this issue, although there could be lobbying on the local government level.

Conclusion:

Pursuant to County Ordinance No.00-64, "no person or entity that received compensation from the County for lobbying on behalf of the County or any of its agencies or instrumentalities at either the state, national or municipal level shall represent any entity in any forum to support a position in opposition to a position of the County unless the Board grants a specific waiver for a specific lobbying activity."

Additionally, County Resolution No. 56-10 requires all County contract lobbyists to obtain a waiver from the Board for any actual or perceived conflicts of interest.

The Ethics Commission is appreciative of the fact that these attorneys disclosed their perceived conflict. The Commission is of the opinion that the question of whether or not to grant a waiver regarding current lobbying activities is largely moot at this point since the legislative session

has ended and the pre-emption language in HB 7087/SB740 did not become law. However, the issue remains alive and is likely to recur during the 2019 legislative session.

The representation of the pet industry by Messrs. Book, Diaz and Pittman necessarily requires them to support a position directly opposite to the County's longstanding, principled position on pre-emption. Any time that a recognized advocate for the County's interests is simultaneously advocating, within the same legislative arena, a position inimical to its interests, the credibility and effectiveness of the County's overall legislative lobbying efforts are impaired. The Ethics Commission staff recommends that no waiver be granted to Messrs. Book, Diaz or Pittman on this issue for the 2019 legislative session.


Dear Jess:

As I believe you are aware, I have historically represented the retail Pet Store Industry. I have represented the Pet Industry for many years, both locally and at the state level.

My firm's representation, at the local level has been well documented over the years, as I have worked to create a framework of reasonable regulation of pet stores and the sourcing of pets. I have worked hard, at the local levels to oppose, the banning of the sale of puppies and kittens. Over the last year, we have had a lot of dialogue with both local and state officials, in trying to craft a compromise that would create reasonable regulation that would avoid preemption, however, out of that, has come a provision currently contained in the House Tax Bill that would reverse the trend of abolishing the sale of puppies and kittens locally. There is a lobbying team that is assembled that I am overseeing. I am working to avoid actual lobbying but I am supervising the lobbying team. Out of an abundance of caution, I am submitting this letter to request a lobbying waiver on this matter.

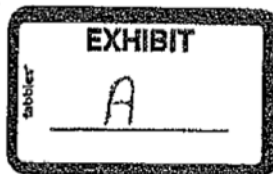

Please know, we value our representation of Miami-Dade County.

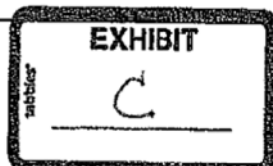
