RESOLUTION CALLING A COUNTYWIDE SPECIAL ELECTION IN MIAMI-DADE COUNTY, FLORIDA, TO BE HELD IN CONJUNCTION WITH A GENERAL ELECTION ON TUESDAY, NOVEMBER 6, 2018, FOR THE PURPOSE OF SUBMITTING TO THE ELECTORS OF MIAMI-DADE COUNTY THE QUESTION OF WHETHER TO AMEND THE HOME RULE CHARTER TO REPLACE THE OFFICE OF THE COMMISSION AUDITOR WITH THE COMMISSION OFFICE OF BUDGET AND RESEARCH

WHEREAS, on March 20, 2017, this Board approved Resolution No. R-304-17 creating a Charter Review Task Force to review the Home Rule Charter of Miami-Dade County in its entirety and to prepare and submit written recommendations to the Board of County Commissioners setting forth any proposed amendments or revisions to the Charter; and

WHEREAS, on February 28, 2018 the Charter Review Task Force transmitted a final report recommending that this Board place proposed changes to the Miami-Dade County Home Rule Charter before the electorate of the County; and

WHEREAS, among the issues studied by the Charter Review Task Force was whether the Office of the Commission Auditor should be changed to the Commission Office of Budget and Research ("OBR"); and

WHEREAS, Section 9.10 of the Miami-Dade Home Rule Charter currently provides for an Office of the Commission Auditor which is led by the Commission Auditor who must be a certified public accountant and who shall, among other things, provide the Commission with independent budgetary, audit, management, revenue forecasting, and fiscal analysis of commission policies, County services, and County contracts; and

WHEREAS, the Charter Review Task Force found that changing the current Office of the Commission Auditor to the Commission Office of Budget and Research led by a director who is not required to be a certified public accountant will better focus the Office on the important tasks of preparing and assisting the Board of County Commissioners in its review of the County budget, legislation, policy and contracts; and

WHEREAS, the Charter Review Task Force, by a vote of six in favor and two against, recommends that the Office of the Commission Auditor should be changed to the Commission Office of Budget and Research; and

WHEREAS, this Board desires to place this issue before the voters on the November 6, 2018 General Election Ballot,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. A countywide special election is hereby called and shall be held in Miami-Dade County, Florida in conjunction with a General Election on Tuesday, November 6, 2018, for the purpose of submitting to the qualified electors of Miami-Dade County the proposal for amendment to the Home Rule Charter in the form attached hereto and made a part hereof.

Section 2. Notice of such election shall be published in accordance with Section 100.342, Florida Statutes.

Section 3. The result of such election shall be determined by a majority of the qualified electors of Miami-Dade County voting upon the proposal. The polls at such election shall be open from 7:00 a.m. until 7:00 p.m. on the day of such election. All qualified electors of Miami-Dade County, Florida shall be entitled to vote at said election. The County registration

books shall remain open at the Office of the Miami-Dade County Supervisor of Elections until twenty-nine (29) days prior to the date of such election, at which time the registration books will close in accordance with the provisions of general election laws. The question shall appear on the ballot in substantially the following form:

CHARTER AMENDMENT REPLACING OFFICE OF COMMISSION AUDITOR WITH THE COMMISSION OFFICE OF BUDGET AND RESEARCH

SHALL THE OFFICE OF THE COMMISSION AUDITOR BE REPLACED BY THE COMMISSION OFFICE OF BUDGET RESEARCH ANDWHICH SHALL PERFORM SUCH **FUNCTIONS** AS **DETERMINED** BYTHE **BOARD** INCLUDING, BUT NOT LIMITED TO, INDEPENDENT BUDGETARY, AUDIT, MANAGEMENT, ANALYSIS OF REVENUE FORECASTING, AND FISCAL ANALYSES AND **COMMISSION** RESEARCH OF POLICIES, **COUNTY** SERVICES AND CONTRACTS AND SHALL NO LONGER BE REQUIRED TO BE LED BY A CERTIFIED PUBLIC ACCOUNTANT?

Section 4. The form of the ballot shall be in accordance with the requirements of general election laws.

Section 5. Early voting shall be conducted in accordance with the requirements of general election laws.

Section 6. Absentee paper ballots may be used by qualified electors of Miami-Dade County for voting on this question. The form of such absentee ballot shall be in accordance with the requirements prescribed by general election laws.

Section 7. A sample ballot showing the manner in which the question or proposal aforesaid will appear at this election shall be published and provided in accordance with the applicable provisions of general election laws.

Section 8. This special election on the proposal aforesaid shall be held and conducted in accordance with applicable provisions of the general laws relating to elections and the provisions of the Miami-Dade County Home Rule Charter. The County Mayor or his or her designee, the Finance Director, and the Clerk of the County Commission are hereby authorized and directed to take all appropriate actions necessary to carry into effect and accomplish the provisions of this resolution. This election shall be a nonpartisan election. Election officials in connection with this election shall be appointed in accordance with the provisions of general election laws.

Section 9. This election shall be canvassed by the County Canvassing Board, in accordance with the provisions of Section 3.07 of the Home Rule Charter.

The Prime Sponsor of the foregoing resolution is Chairman Esteban L. Bovo, Jr. It was offered by Commissioner , who moved its adoption. The motion was seconded by Commissioner and upon being put to a vote, the vote was as follows:

MIAMI-DADE COUNTY HOME RULE CHARTER

ARTICLE-91

GENERAL PROVISIONS

SECTION 9.10. COMMISSION [[AUDITOR]] >> OFFICE OF BUDGET AND RESEARCH <<.

There is hereby created and established the Office of [[the Commission Auditor]] >> Budget and Research <<. The [[Commission Auditor, who shall be a certified public accountant,]] >> Director of the Office of Budget and Research << will be selected by the County Commission and shall report directly to the County Commission. The County Commission shall provide by ordinance for the specific functions and responsibilities of the [[Commission Auditor]] >> Office of Budget and Research <<, which shall include but not be limited to providing the Commission with independent budgetary, audit, management, >> analysis of << revenue forecasting, [[and]]fiscal analyses >> and research << of commission policies, and county services and contracts.
