Assistant County Attorney Bruce Libhaber read the title of the foregoing proposed ordinance into the record.

Chairman Moss opened the public hearing.

Upon seeing no one else wishing to speak, Vice Chairman Moss closed the public hearing.

As a point of personal privilege, Commissioner Sosa acknowledged and thanked Miami-Dade's Department of Transportation and Public Works (DTPW) and the Office of Emergency Management (OEM) for responding promptly and efficiently to an emergency in her Commission District which involved senior citizens. She noted due to an electrical issue at a building, all the residents were forced to evacuate the building and without the services provided by DTPW and OEM the residents would have been stranded outside in the sweltering heat without relief.

Returning to the item before the Committee, Commissioner Sosa provided a brief review of the intent of the item, noting the foregoing proposed ordinance sought to allow special transportation service (STS) providers to self-certify that their vehicles are in compliance with the vehicle standards provisions of the Code.

Assistant County Attorney Libhaber confirmed that the same inspection requirements applied to taxis as well.

Commissioner Higgins asked whether the County would still be able to perform spot inspections.

Both Commissioner Sosa and Assistant County Attorney Libhaber reassured the Committee members that the County maintained the right to perform spot inspections.

Revisiting the incident which occurred in Commission District 6 and resulted in DTPW sending buses to provide relief to the affected residents, Chairman Moss spoke about the possibility of drafting legislation under the leadership of Commissioner Sosa which would direct DTPW to respond similarly to other emergencies.

Ms. Alice Bravo, Director, Department of Transportation and Public Works (DTPW) recounted a separate incident where DTPW provided similar service.

Commissioner Sosa reiterated her appreciation for the services provided by DTPW in response to emergencies.

Vice Chairman Moss urged his colleague, Commissioner Sosa to take the lead in creating the necessary legislation.

There being no further questions or comments, the members of this Committee proceeded to take a vote on the foregoing proposed ordinance, as presented.

Report:

Commissioner Heyman stated that while she was concerned about the promises made to the public in the Peoples' Transportation Plan (PTP) and the fact that only one project had been completed in its entirety to date, she believed the metro-mover fee-free component needed to be reviewed and reevaluated given the massive amounts of development which have taken place along the routes and requested the item be waived to the July 24, 2018 County Commission meeting if adopted.

Commissioner Sosa argued that the PTP funds had not been utilized in the manner in which the public voted for them to be used and read into the record the ballot question posed to the public regarding the establishment of the fund and its intended uses. She indicated her intent to sponsor legislation which would allow the Department of Transportation and Public Works (DTPW) to use funds from the PTP to cover operational costs and called for a workshop to develop a realistic transit plan. Commissioner Sosa expressed concerns regarding the fiscal impact to the most vulnerable users of the metro-mover system if a fee were to be implemented and the ongoing misuse of PTP funds by municipalities. She noted that while she could not support the item as presented, she would support an overall re-evaluation of the plan and review of alternative solutions.

Commissioner Heyman argued that the foregoing proposed resolution was the first step to gathering information which could then be reviewed and discussed in a workshop, and agreed to defer the foregoing proposed resolution to no date certain.

Wednesday, July 18, 2018

She requested Ms. Alice Bravo, Director, Department of Transportation and Public Works (DTPW) begin compiling pertinent statistical information in preparation for a more in-depth discussion or workshop.

Commissioner Higgins echoed the sentiments expressed by Commissioner Sosa regarding the impact of imposing a fee/increasing rates for metro-mover service on the working population and pointed out the elimination of the fare resulted in increased usage and ridership.

In response to Commissioner Higgins' question regarding the existing fare collection technology available to the public, Ms. Bravo explained the "easy pay" system currently in place and noted that the department would evaluate whether there were other lower cost alternatives to the existing "easy pay" system which could be implemented.

Vice Chairman Moss stated that he would not support changes to the PTP without first putting the proposed changes to a public vote.

There being no further questions or comments, the Committee proceeded to vote on the motion to defer the item to no date certain.

Commissioner Sosa recognized the Citizens' Independent Transportation Trust (CITT) for their role in designing the "half penny" logo to be placed on all County and municipal trolleys, buses and projects funded in whole or in part with PTP funds.

Assistant County Attorney Bruce Libhaber read the title of the foregoing proposed resolution into the record.

Commissioner Sosa inquired about the types of buses being purchased, how they would be utilized; specifically whether they would be used to replace older model buses; and where they would be dispatched from.

Ms. Alice Bravo, Director, Department of Transportation and Public Works (DTPW) advised the Committee members that the Board of County Commissioners (BCC) had previously approved the acquisition of 300 Compressed Natural Gas (CNG). She noted that the new buses were 40 foot conventional buses and anticipated they would be dispatched from the Coral Way Maintenance Facilities and the central maintenance facility.

Commissioner Sosa voiced her concerns regarding the practicality of articulated buses and stated her intent to request a study to evaluate high ridership areas where they should be assigned.

Ms. Bravo reassured the Committee members that older buses were being retired and replaced with the new model.

Vice Chairman Moss asked whether the department had ever considered using double decker buses.

Meeting Minutes

Ms. Bravo expressed apprehension about using double decker buses based on ADA accessibility concerns and vertical clearance issues, but agreed the idea was worth exploring.

Commissioner Moss argued that the first floor of the double decker bus should be sufficient to satisfy ADA compliance requirements and pointed out that double decker sightseeing buses already operated throughout Downtown Miami with no problems.

Addressing Commissioner Sosa's concerns regarding articulated buses, Ms. Bravo noted that the new articulated buses were assigned to heavy ridership corridors such as South Dade Transit Way, Biscayne Boulevard and Collins Avenue with much success; and noted there was one corridor in which there was not enough ridership to fill the articulated bus but due to a funding grant requirement for the corridor the articulated bus service needed to remain.

Ms. Bravo agreed that articulated and double decker buses provided operational savings and reassured the Committee members that DTPW would continue to explore all options.

There being no further questions or comments, the members of this Committee proceeded to take a vote on the foregoing proposed resolution, as presented.

Report:

Assistant County Attorney Bruce Libhaber read the title of the foregoing proposed resolution into the record.

Commissioner Heyman stated while she was in support of the additional expenditure amount requested (\$1,600,000.00); she was concerned about the deplorable condition of the awnings and canopies covering bus shelters throughout the County and questioned how much funds was left from the original allocation amount of \$6,476,00.00.

Ms. Alice Bravo, Director, Department of Transportation and Public Works (DTPW) explained that out DTPW had exhausted the \$355,000.00 allocated to the department.

Commissioner Heyman asked whether the entire \$1,600,000.00 would be allocated solely to DTPW to outfit bus stops with protective cover.

Ms. Bravo reported that the money would be used to replace canopies along the South Dade Transit Way Corridor damaged by last year's hurricanes.

Commissioner Heyman asked whether the amount requested would be enough to complete repairs to all derelict canopies and awnings throughout the County.

Ms. Bravo confirmed that the requested amount was enough to complete County wide repairs.

Vice Chairman Moss questioned the reason for the delay in replacing/repairing the canopies/awnings.

Ms. Bravo explained that DTPW conducted structural inspections to determine whether the damaged canopies could be retrofitted with a metal roof and upon discovery that this could not be done proceeded to identify a vendor to replace the damaged canopies. She noted issues with

securing the necessary replacement material due to the high demand for the product caused a delay in the installation of the canopies but reassured the Committee members that the material has since been secured and installation should begin within 2 weeks.

Responding to Vice Chairman Moss' question as to what could be done to prevent this issue from reoccurring in the future, Ms. Bravo suggested preordering and stockpiling the material.

Commissioner Heyman inquired whether the requested allocation amount (\$1.6 million) was included in the County's request package for reimbursement to the Federal Emergency Management Agency (FEMA) in light of the fact that the damages were hurricane related.

Ms. Bravo noted that any reimbursement would be received through the Federal Transit Administration (FTA).

Deputy Mayor Alina Hudak clarified that all claims were subject to FEMA review. Discussion ensued between Commissioner Heyman and Ms. Bravo regarding the extent of repairs to be made.

Deputy Mayor Hudak urged Commissioner Heyman to identify specific sites which may need repairs, otherwise not listed by the department.

Commissioner Heyman pointed to the language of the item and questioned whether a county-wide assessment had been performed.

Ms. Bravo reassured the Committee members that the County's entire transit system had been inspected for damages.

Commissioner Sosa suggested creating a memorandum of understanding which would allow the department to utilize local vendors to complete repairs during emergencies such as hurricanes and questioned what was being done to expedite FEMA reimbursements.

Discussion ensued between Commissioner Sosa and Ms. Bravo about the language of the item, the location of damaged canopies specific to the South-Dade Transit Way and DTPW's evaluation to determine whether the damaged canopies could be retrofitted with metal roofs to prevent future storm damages.

Commissioner Sosa suggested DTPW explore planting trees close to bus stops to help provide natural shade for the area.

Vice Chairman Moss pointed out that "Neat Streets Miami" was currently working alongside DTPW to plant trees close to bus stops.

Responding to Vice Chairman Moss' question as to whether none of the local vendors in the pool had the canopy material on hand, Ms. Bravo noted that the vendor hired to complete the installation, like all other local vendors had to special order the material.

There being no further questions or comments, the Committee proceeded to vote on the foregoing proposed resolution as presented.

Ms. Alice Bravo, Director, Department of Transportation and Public Works (DTPW), requested the foregoing proposed resolution be waived to the July 24, 2018 County Commission meeting.

Vice Chairman Moss asked staff to prepare the appropriate memorandum requesting that Board of County Commissioners (BCC) Chairman Esteban L. STATUS REPORT REGARDING BUS TOUR PERFORMED ON JULY 17, 2018 Presented

Report:

Vice Chairman Moss requested Ms. Bravo, Director, Department of Transportation and Public Works (DTPW), to provide the Committee members with a brief report regarding the bus tour performed yesterday (7/17).

Ms. Bravo, Director for DTPW, reminded the Committee members that last year the Board of County Commissioners (BCC) had approved the installation of smart signals along 10 of the County's most congested transit corridors. She noted that while the equipment had been installed Countywide, DTPW focused on the South Dade Transit Way and the express bus service to evaluate the success of the adaptive smart signals and the transit signal priority (TSP) technology. Ms. Bravo explained how the TSP technology functioned and reported since the implementation of the technology, the "34 Express Bus" from Florida City to the Dadeland South station realized a time savings of 17 minutes per trip reducing the commute from 67 minutes to 50 minutes with buses having to stop at only 13 out of 46 signals.

Ms. Bravo commended the County's DTPW, Internal Services Department (ISD) and Information Technology Department (ITD) for working together to make the project a success.
