Commissioner Higgins inquired if driving while intoxicated would also include the beaches, specifically Miami Beach. In addition, she asked if the Police Department reported a growing problem of people driving while intoxicated at our County parks.

Ms. Maria Nardi, Parks, Recreation and Open Spaces (PROS) Department Director, addressed Commissioner Higgins concerns, noting PROS will look into park signage and review information regarding intoxication statistics with the Police Department.

Commissioner Souto stated that a problem existed with intoxicated people at parks throughout the County, noting they could be arrested if driving with an alcohol level above the legal limit. He commented on issues related to increased local traffic and distracted drivers. Commissioner Souto stated he would not want to see anyone driving out of a park intoxicated and subsequently involved in an accident.

The title of the foregoing proposed ordinance was read into the record by Assistant County Attorney Miguel Gonzalez.

Commissioner Diaz asked Assistant County Attorney Jorge Martinez-Esteve to explain this item in further detail as it related to cost. He also inquired if the election process was required or if this change could occur through a vote of their Commission or entity.

Assistant County Attorney Jorge Martinez-Esteve explained that County Code currently required a vote of registered voters living within the affected district to transfer a Special Taxing District to a municipality. He noted a two-thirds majority vote of the Board of County Commissioners and the relevant municipality's council or commission was needed to waive the election requirement. Assistant County Attorney Martinez-Esteve clarified that this legislation would eliminate the election requirement under certain circumstances. He added that district residents would not incur the cost of an election, upon approval of this item.

Commissioner Higgins inquired if this item was related to commercial areas that lacked residents.

Assistant County Attorney Martinez-Esteve advised Committee members if there were registered voters in a commercial area, the voters would have to appear and vote to get their particular district transferred.

Ms. Lorena Guerra-Macias, Special Assessment District Chief, Miami-Dade Parks and Recreation Department, addressed Commissioner Higgins concerns, noting there were certain districts that were entirely commercial with no registered voters in and others with just a few registered voters.

Discussion ensued between Commissioner Diaz and Assistant County Attorney Martinez-Esteve regarding the circumstances requiring an election, the 2/3 vote waiver requirement and other conditions requiring the County Mayor's discretion or recommendation.

Assistant County Attorney Martinez-Esteve stated the rule was broadly written to cover all areas to foresee where a waiver may be needed to present unfair voter situations to the Board.

Commissioner Diaz stated he was satisfied with Assistant County Attorney Martinez-Esteve's explanation, noting he would support this item.

There being no further questions or comments, the Committee proceeded to vote on the foregoing proposed ordinance.
