Miami-Dade County Opioid Response Partnership Expansion Project Application

RECOMMENDATION

It is recommended that the Board of County Commissioners (Board) approve this item, which does the following:

- Ratifies the action of the County Mayor or the County Mayor's designee, acting as the fiscal agent for the Eleventh Judicial Circuit of Florida as authorized by Resolution No. R-79-03, in applying for grant funds from the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration (SAMHSA) in the amount of \$2,000,000,00 for the Miami-Dade County Opioid Response Partnership Expansion Project;
- Authorizes the County Mayor or the County Mayor's designee, as the fiscal agent of the Eleventh Judicial Circuit of Florida, to execute any amendments to the grant application; to receive any grant funds that are awarded in response to this application; to execute such contracts, agreements, memoranda of agreements, and amendments as may be required by program guidelines, and to exercise termination and modification clauses of any such contracts and agreements, subject to the County Attorney's Office's approval; and
- Authorizes the County Mayor or the County Mayor's designee, as fiscal agent for the Eleventh Judicial Circuit, to apply for and receive additional future funds that may become available under this program; to execute such contracts, agreements, memoranda of agreements, and amendments, and to exercise termination and modification clauses of any such contracts and agreements, subject to the County Attorney's Office's approval.

SCOPE

The County, through the Office of Management and Budget, Grants Coordination Division (OMB-GCD), as fiscal agent of the Eleventh Judicial Circuit, applied for a grant from SAMHSA in the amount of \$2,000,000.00 for the Miami-Dade County Opioid Response Partnership Expansion Project. The grant will enable the Adult Drug Court to increase treatment and recovery support for offenders using other substances and/or alcohol in addition to those with substance use disorder and mental health problems, to promote successful stabilization and comprehensive recovery. The Eleventh Judicial Circuit, as lead partner, formed a collaborative partnership with Jackson Health System, to provide treatment to project participants, and the Behavioral Science Research Institute, to conduct the required project evaluation. Jackson Health System will receive a subaward of \$298,116.00, and the Behavioral Science Research Institute will receive a subaward of \$20,000.00.

### FISCAL IMPACT/FUNDING SOURCE

The grant request is for \$2,000,000.00. There is no fiscal impact to the County to serve as the fiscal agent for the Eleventh Judicial Circuit for this grant project, as existing staff will be used to facilitate this project. The grant does not require matching funds.

#### TRACK RECORD/MONITOR

The OMB-GCD and the Eleventh Judicial Circuit have an extensive history of managing grant projects and will coordinate project implementation and management. OMB-GCD will monitor the project and serve as liaison with SAMHSA. The Eleventh Judicial Circuit will handle project drawdowns through SAMHSA in concert with the County's Finance Department; process the disbursement and expenditure of grant funds; and, manage programmatic and fiscal reporting in accordance with project reporting and auditing procedures stipulated by SAMHSA.

#### **BACKGROUND**

In collaboration with Miami-Dade County, the Eleventh Judicial Circuit Adult Drug Court program and its partners, the Jackson Health System and the Behavioral Science Research Institute, will implement the Opioid Response Partnership Expansion project. The purpose of the project is to include treatment and recovery support for offenders using other substances and/or alcohol, in addition to opioid use disorder and/or those with substance use disorder and mental health problems, to promote successful stabilization and comprehensive recovery. The project will serve 200 clients — 40 per year over five years.

The Adult Drug Court and its project partners seek to achieve three (3) goals: 1) expand access to outpatient medication assisted treatment and comprehensive mental health services to individuals with a primary opioid use disorder diagnosis, including opioids, and/or substance use disorder plus a co-occurring mental health diagnosis; 2) expand access to outpatient medication assisted treatment and comprehensive mental health services to individuals with a primary substance use disorder diagnosis, including alcohol, and/or substance use disorder plus a co-occurring mental health diagnosis; and, 3) expand and improve access to opioid and substance abuse treatment and services for participants with a primary diagnosis of substance use disorder, including opioids and alcohol, and/or substance use disorder plus a mental health diagnosis while incarcerated to facilitate stabilization and rehabilitation upon release.

The short turnaround time imposed by the SAMHSA application deadline did not allow sufficient time for the processing of the resolution and its submission to the Board prior to submission of the grant application.

This Board also authorizes the County Mayor or the County Mayor's designee, as fiscal agent for the Eleventh Judicial Circuit of Florida, to apply for and receive additional future funds that may become available for the Miami-Dade County Opioid Response Partnership Expansion Project, to execute any contracts, agreements, memoranda of agreement, or amendments that may be necessary for the receipt of additional available funds for this project, and to exercise termination and modification provisions contained therein, subject to the County Attorney's Office's approval.
