RECOMMENDATION

It is recommended that the Board of County Commissioners (Board) approve this item, which does the following:

- · Ratifies the County Mayor or the County Mayor's designee's action, acting as the fiscal agent for the Eleventh Judicial Circuit of Florida as authorized by Resolution No. R-79-03, in applying for grant funds from the United States Department of Justice (DOJ), Office of Violence Against Women, in the amount of \$530,277.00 for the Miami-Dade Domestic Violence Court Victim Advocacy Enhancement Project;
- Authorizes the County Mayor or the County Mayor's designee, as the fiscal agent for the Eleventh Judicial Circuit of Florida, to execute any amendments to the grant application, to receive any grant funds that are awarded in response to this application; to execute such contracts, agreements, memoranda of agreements, and amendments as may be required by program guidelines; and, to exercise termination and modification clauses of any such contracts and agreements, all of which are subject to the County Attorney's Office's approval.
- Authorizes the County Mayor or the County Mayor's designee, as fiscal agent for the Eleventh Judicial Circuit of Florida, to apply for and receive additional future funds that may become available under this program; to execute such contracts, agreements, memoranda of agreements, and amendments as may be required by the County to act as fiscal agent for the Eleventh Judicial Circuit with respect to such future available funds, after review by the County Attorney's Office for form and legal sufficiency; and to exercise termination and modification clauses of any such contracts and agreements, subject to the County Attorney's Office's approval.

SCOPE

The County, through the Office of Management and Budget, Grants Coordination Division (OMB-GCD), on behalf of the Eleventh Judicial Circuit, applied for a grant from DOJ in the amount of \$530,277.00 for the Miami-Dade Domestic Violence Court Victim Advocacy Enhancement Project. The Eleventh Judicial Circuit, as lead partner, formed a collaborative partnership with the County's Community Action and Human Services Department, Coordinated Victims Assistance Center (CVAC) to implement the project. The DOJ grant project will support enhanced courtbased programs and services, to improve court responses to domestic violence, dating violence, sexual assault, and stalking.

The grant will enable the Domestic Violence Court to increase treatment access and enhance services to an average of 9,000 victims who file cases annually, over the three-year grant period.

FISCAL IMPACT/FUNDING SOURCE

The grant request is for \$530,277.00. There is no adverse fiscal impact to the County to serve as the fiscal agent of the Eleventh Judicial Circuit for this grant project. The grant does not require matching funds. As project partner, CVAC will receive a subaward of \$455,761, for three (3) CVAC positions, fringe benefits, travel, supplies, and other related project costs, over three years.

TRACK RECORD/MONITOR

The OMB-GCD and the Eleventh Judicial Circuit have an extensive history of managing grant projects and will coordinate project implementation and management. OMB-GCD will monitor the project and serve as liaison with the DOJ. The Eleventh Judicial Circuit will handle project drawdowns through DOJ in concert with the County's Finance Department; process the disbursement and expenditure of grant funds; and manage programmatic and fiscal reporting in accordance with project reporting and auditing procedures stipulated by DOJ.

BACKGROUND

In collaboration with Miami-Dade, the Eleventh Judicial Circuit Domestic Violence Court program and its partner, CVAC, plan to implement a service capacity enhancement project designed to provide court-based victim advocates to address domestic violence countywide. The court will partner with CVAC, a one stop victims assistance provider center, whose primary purpose is to provide comprehensive and coordinated victim services to victims of domestic violence. CVAC has approximately 40 on-site partners that provide an array of services, including mental health and substance abuse services for victims of domestic violence.

For the County, this will be an extremely significant court enhancement that directly addresses the safety and well-being of domestic violence victims, including victims of human trafficking and stalking, and promotes sound judicial decision making.

The short turnaround time imposed by the DOJ's application deadline did not allow sufficient time for the processing of the resolution and its submission to the Board prior to submission of the grant application.

This Board also authorizes the County Mayor or the County Mayor's designee, as fiscal agent for the Eleventh Judicial Circuit of Florida, to apply for and receive additional future funds that may become available for the Miami-Dade Domestic Violence Court Victim Advocacy Enhancement Project, to execute any contracts, agreements, memoranda of agreement, or amendments that may be necessary for the receipt of additional available funds for this project, and to exercise termination and modification provisions contained therein, subject the County Attorney's Office's approval.
