RESOLUTION ESTABLISHING COUNTY POLICY TO INCREASE THE NUMBER OF PARK MANAGERS TO ADEQUATE STAFFING LEVELS; DIRECTING THE COUNTY MAYOR OR THE COUNTY MAYOR'S DESIGNEE TO INCLUDE A SUFFICIENT FUNDING AND STAFFING FOR THE IMPLEMENTATION OF SUCH POLICY AS PART OF THE COUNTY MAYOR'S PROPOSED FY 2019-2020 COUNTY BUDGET AND TO PROVIDE A REPORT

WHEREAS, Miami-Dade Parks, Recreation and Open Spaces Department ("PROS") currently manages an inventory of 272 parks across Miami-Dade County; and

WHEREAS, visitors and residents alike enjoy the natural beauty and recreational and program ming opportunities provided at County parks; and

WHEREAS, currently there are 153 park managers, of which 114 are full-time and 39 are part-time, employed by PROS to supervise and manage the parks; and

WHEREAS, park managers are essential to ensuring that our park system is maintained in an orderly, clean, and safe manner; and

WHEREAS, the County's 153 park managers are currently responsible for overseeing over 270 parks and may only be able to visit individual parks on a weekly basis; and

WHEREAS, approximately 45 park managers oversee our 185 local parks and 39 managers oversee our 87 area-wide parks; and

WHEREAS, the current ratio of park managers to local parks and area-wide parks does not facilitate park manager's ability to frequently attend the County's parks; and

WHEREAS, an increase in staffing levels at County parks would improve programming, security, and maintenance at parks, and this Board desires to have vibrant, well-staffed, and well-maintained parks,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Incorporates and approves the above recitals as if fully set forth herein.

Section 2. Establishes a policy to increase the number of park managers to a level that supports (1) an increased number of permanent park managers at all area-wide parks and (2) an increased number of park managers making twice-weekly visits to all local parks.

Section 3. Directs the County Mayor or County Mayor's designee to, include sufficient funding and staffing for the implementation of the policy set forth in Section 2 in the Mayor's proposed Fiscal Year 2019-2020 County Budget.

Section 4. Directs the County Mayor or County Mayor's designee to provide a written report, regarding the directive set forth in Section 2, including the availability of funding and the impact on quality of service provided by our parks as determined by PROS, to the Board within 60 days of the effective date of this resolution, which shall be placed on an agenda of the Board pursuant to Ordinance No. 14-65.

The Prime Sponsor of the foregoing resolution is Commissioner Xavier L. Suarez. It was offered by Commissioner , who moved its adoption. The motion was seconded by Commissioner and upon being put to a vote, the vote was as follows:
