RESOLUTION CODESIGNATING, BY A THREE-FIFTHS VOTE OF BOARD MEMBERS PRESENT, THAT PORTION OF NW 16TH AVENUE FROM NW 143RD STREET TO SOUTH RIVER DRIVE, THAT PORTION OF SOUTH RIVER DRIVE FROM NW 16TH AVENUE TO NW 153RD STREET, AND THAT PORTION OF NW 153RD STREET FROM SOUTH RIVER DRIVE TO NW 7TH AVENUE/STATE ROAD 7 AS "DR. SOLOMON STINSON STREET"

WHEREAS, Dr. Solomon Stinson, former chairman and former member of the Miami-Dade County School Board, devoted 36 years of outstanding and dedicated service as an educator, role model, and mentor to help shape thousands of children's lives; and

WHEREAS, Dr. Stinson earned a Bachelor's degree in social studies, mathematics, and science certification from Alabama State University, a Master's degree in school administration and supervision from the University of Iowa, and a Doctoral degree in school administration from the University of Iowa; and

WHEREAS, Dr. Stinson also received a certification in elementary education from the University of Miami and a certification in adult education from Florida State University; and

WHEREAS, Dr. Stinson began his career by teaching at Holmes Elementary School where he quickly advanced to become the assistant principal at Rainbow Park and North Glade Elementary Schools, and later principal at North Glade and Lake Steven Elementary Schools; and

WHEREAS, Dr. Stinson distinguished himself as an outstanding administrator in the position of assistant superintendent of the Bureau of Business Services with the Miami-Dade County school system; and

WHEREAS, he served in several other important positions in the Miami-Dade County public school system, including area superintendent of the north central district, associate and senior associate superintendent of the bureau of school operations, and deputy superintendent of school operations for Miami-Dade County public schools; and

WHEREAS, Dr. Stinson had an outstanding record as a school board member for Miami-Dade County School Board District 2 and chairman for Miami-Dade County School Board; and

WHEREAS, Dr. Stinson has been extremely active in other areas of the community; he is a member of Mount Tabor Baptist Church, where he has served as chairman of the board of trustees for the last 6 years; he chaired the Hurricane Trust Fund and the Red Cross Committee; he is a member of the board of directors of Jobs for Miami; and he is a committee member and council advisory board member of the Boy Scouts of America; and

WHEREAS, this Board would like to recognize Dr. Stinson for his exceptional service and commitment to Miami-Dade County by codesignating portions of three roads that form a continuous road beginning at NW 143rd Street and ending at NW 7th Avenue, as follows: that portion of NW 16th Avenue from NW 143rd Street to South River Drive, that portion of South River Drive from NW 16th Avenue to NW 153rd Street, and that portion of NW 153rd Street from South River Drive to NW 7th Avenue/State Road 7 as "Dr. Solomon Stinson Street"; and

WHEREAS, NW 16th Avenue from NW 143rd Street to South River Drive, South River Drive from NW 16th Avenue to NW 153rd Street, and NW 153rd Street from South River Drive to NW 7th Avenue/State Road 7 are county roads located in unincorporated Miami-Dade County in County Commission District 2; and

WHEREAS, Rule 9.02(d) of the Board's Rules of Procedure provides that the Board may by a three-fifths vote of members present name a County road, facility or property after a living individual who has not served as an elected official within the past five years and who "has made a direct, significant lifetime contribution to this community,"

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. The foregoing recitals are hereby incorporated into this resolution and the Board finds that Dr. Solomon Stinson has made direct, significant lifetime contributions to this community pursuant to Rule 9.02(d).

Section 2. Having considered this matter at a public hearing, codesignates, by a three-fifths vote of Board members present, that portion of NW 16th Avenue from NW 143rd Street to South River Drive, that portion of South River Drive from NW 16th Avenue to NW 153rd Street, and that portion of NW 153rd Street from South River Drive to NW 7th Avenue/State Road 7 as "Dr. Solomon Stinson Street".

Section 3. Directs the Clerk of the Board to transmit a certified copy of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Transportation and Public Works Department, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade Police Department, and the Miami-Dade Fire Department.

The Prime Sponsor of the foregoing resolution is Commissioner Jean Monestime.
