Recommendation for Approval to Award Railcar Wheel Press Machine, and

Authorizing the Use of Charter County Transportation Surtax Funds for Such Purpose

Recommendation

It is recommended that the Board of County Commissioners (Board) approve a competitive contract award, *Contract No. FB-00743, Railcar Wheel Press Machine*, to BBM Railway Equipment, LLC for the Department of Transportation and Public Works. This contract will provide for the removal of the existing railcar wheel press machine, and the furnishing and installation of a new one.

This item is placed for Board review pursuant to Miami-Dade County Code Section 29-124(f). The Board may only consider this item if the Citizens' Independent Transportation Trust (CITT) has forwarded a recommendation to the Board prior to the date scheduled for Board consideration or 45 days have elapsed since the issuance of this recommendation. If CITT has not forwarded a recommendation and 45 days have not elapsed since the issuance of this recommendation, a withdrawal of this item will be requested.

Background

There is no existing or previous County contract which provides wheel press scope of services. The only wheel press machine that the Department has is currently in operation, and was installed over 35 years ago. As a result, the wheel press machine needs to be repaired frequently and the repairs often take weeks, due to the limited availability of parts. The considerable cost of the repairs leads to a lengthy process, further increasing the down time. When the machine is out of service for repairs, rail cars are rendered unavailable for revenue service and limits the ability to meet the needs of the public. In addition, the new railcar fleet necessitates the purchase since they are heavier than the legacy fleet and require more frequent pressing of the wheels, placing further strain on the machine.

Scope

The scope of this item is countywide in nature.

Fiscal Impact/Funding Source

The fiscal impact is \$980,600 for the purchase of one machine for a one-year term. There is no prior or existing County contract for these goods. This contract is funded by the Charter County Transportation Surtax funds.

Delegated Authority

If this item is approved, the County Mayor or County Mayor's designee will have the authority to exercise all provisions of the contract, including any cancellation and extension provisions, pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38.

Vendor Recommended for Award

An Invitation to Bid was issued under full and open competition, whereby 827 vendors were notified, of which 36 viewed the solicitation, 20 downloaded the solicitation documents and two responded to the solicitation.

Pursuant to disclosure requirements in Resolution No. R-477-18, the vendor recommended for award is a non-local vendor due to no local businesses submitting a bid. Prior to advertisement, the Small Business Development Division advised that there were no certified Small Business Enterprise firms under the commodity for this procurement. In accordance with the method of award, BBM Railway Equipment, LLC is recommended for award as it is the responsible bidder with the lowest priced responsive bid.
