Resolution Authorizing Receipt and Expenditure of a Special Appropriation for \$100,000.00 for Fiscal Year 2019-2020 from the Florida Department of Children and Families and \$50,000.00 from the Town of Surfside; Awarding Funding in the Amount of \$150,000.00 to Non-Profit Provider Camillus House; Authorizing the County Mayor or the County Mayor's Designee to Execute Grants and Sub-Grants and Exercise Modification, Renewal and Termination Clauses Contained Therein; Authorizing the County Mayor or the County Mayor's Designee to Receive and Expend Additional Funds as They May Become Available for the Purposes Set Forth

Herein; and Waiving the Requirements of Resolution No. R-130-06

Recommendation

It is recommended that the Board of County Commissioners (Board) adopt the attached resolution to:

- 1. Authorize the receipt and expenditure of a \$100,000.00 Special Appropriation from the Florida Department of Children and Families and \$50,000.00 from the Town of Surfside for Fiscal Year 2019-2020.
- 2. Award funding in an amount up to \$150,000.00 for Fiscal Year 2019-2020 to non-profit provider Camillus House.
- 3. Authorize the County Mayor or the County Mayor's designee to execute a contract with the Florida Department of Children and Families, and a sub-contract with non-profit housing and service provider Camillus House with an effective date of July 1, 2019, subject to approval by the County Attorney's Office, and to exercise amendments, modifications, cancellation and termination clauses contained in the contract and subcontract.
- 4. Authorize the County Mayor or the County Mayor's designee to receive and expend additional funds as they may become available for the purposes set forth herein; and
- 5. Waive the requirements of Resolution No. R-130-06, which requires the contract to be signed by non-County parties. Given the short timeline provided by the State, it was in the best interest of the County to waive the requirements of Resolution No. R-130-06 and to execute the grant agreement and sub-grant agreements as soon as possible.

Scope

Funding will be administered by the Miami-Dade County Homeless Trust and housing and services will be provided countywide through non-profit sub-grantee Camillus House, pursuant to guidelines and applicable regulations.

Fiscal Impact/Funding Source

The Florida Department of Children and Families (DCF) will reimburse the Homeless Trust for allowable expenditures incurred pursuant to the contract for a total dollar amount not to exceed \$100,000.00 for Fiscal Year 2019-2020. The Town of Surfside will provide funding not to exceed \$50,000.00 for Fiscal Year 2019-2020. Funding will provide Rapid Rehousing, which is short- to medium-term rental assistance with support services, for homeless persons with severe mental illness (SMI) involved in the criminal justice system.

Track Record/Monitor

The Homeless Trust's Executive Director Victoria Mallette will be responsible for overseeing the grants awarded to non-profit service providers.

Background

During the Fiscal Year 2019 Legislative Session, the Miami-Dade County Homeless Trust was awarded \$100,000.00 through the Florida Department of Children and Families (DCF) Rapid Rehousing (RRH) funds to assist homeless persons with severe mental illness. Additionally, the Town of Surfside, which is currently exempted from the one percent Food and Beverage Tax, appropriated \$50,000.00 to the Miami-Dade County Homeless Trust for homeless housing and services. If approved by the Board of County Commissioners, funding from DCF and the Town of Surfside will be used to provide up to 24 months of rental assistance and support services to homeless persons with SMI involved in the criminal justice system, many of whom have a history of arrest or frequent police interactions. Referrals are to be made by the 11th Judicial Circuit Criminal Mental Health Project, jail diversion behavioral health treatment providers, area police departments, and specialized homeless outreach teams. By diverting individuals with SMI from the justice system into housing, there is a reduction in jail costs and fewer admissions to crisis stabilization units/forensic treatment facilities.

Currently, non-profit provider Camillus House receives referrals from the 11th Judicial Circuit Criminal Mental Health Project for the Crisis Outplacement Bed (COB) Program, funded through South Florida Behavioral Health Network, which provides temporary housing and wraparound behavioral health treatment and support services for criminally involved homeless individuals with SMI. The newly appropriated RRH funding will largely help to exit persons in the COB Program to permanent housing, but also will allow direct placement of criminally involved SMI persons into permanent housing with wrap-around supportive services to ensure housing stability.

Housing and services are set to begin on July 1, 2019. In an effort to execute grant and sub-grant agreements by the start of the state's Fiscal Year, the Homeless Trust is seeking to waive the requirements of Resolution No. R-130-06, which requires the contract to be signed by non-County parties.

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

- Section 1. Authorizes the County Mayor or County Mayor's designee to receive and expend funds awarded, including \$100,000.00 awarded through the Florida Department of Children and Families for Fiscal Year 2019-2020; and \$50,000.00 from the Town of Surfside.
- Section 2. Awards funds in an amount up to \$150,000.00 for Fiscal Year 2019-2020 to non-profit housing and service provider Camillus House.
- Section 3. Authorizes the County Mayor or the County Mayor's designee to execute a contract with the Florida Department of Children and Families and sub-contract with non-profit

housing and service provider, Camillus House. The County Mayor or the County Mayor's designee is further authorized to exercise amendments, modifications, cancellation, and termination clauses contained in the contract and subcontract.

Section 4. Authorizes the County Mayor or the County Mayor's designee receive and expend additional funds as they may become available for the purposes set forth herein.

Section 5. Waives the requirements of Resolution No. R-130-06 for the reasons stated in the accompanying memorandum.
