The Board of County Commissioners' adoption of Ordinance 14-44 provides for the creation of a nine (9) member Jackson Health System General Obligation Bond (G.O.B.) Citizens' Advisory Committee.

The Ordinance further provides that the Board may ratify the appointment of four (4) advisory committee members designated by the President of the League of Cities; Chairperson of the Miami-Dade Legislative Delegation; Mayor of Miami-Dade County; Jackson Health Systems Labor Union; and an ex-officio member appointed by the Chairperson of the Public Health Trust Board of Trustees.

The Clerk has received the name of Ms. Jennifer Moon, as designated by the Mayor of Miami-Dade County Carlos A. Gimenez, to serve as a member of the Jackson Health System (G.O.B.) Citizens Advisory Board Committee.
