RESOLUTION WAIVING, BY A TWO-THIRDS VOTE OF THE FULL MEMBERSHIP OF THE BOARD, THE RESIDENCY REQUIREMENT OF SECTION 2-11.38 OF THE CODE OF MIAMI-DADE COUNTY, FLORIDA, FOR ARTHUR ROSENBERG, BOARD MEMBER OF THE MIAMI-DADE COUNTY LIVING WAGE COMMISSION

WHEREAS, this Board established the Living Wage Commission to review the effectiveness of the Living Wage Ordinance, review certifications submitted by covered employers, review complaints filed by employees and make recommendations to this Board, the County Mayor and County departments; and

WHEREAS, the Living Wage Commission is a County board as provided by section 2-

11.36.1 of the County Code; and

WHEREAS, pursuant to section 2-11.38 of the County Code, all members of County

boards shall be permanent residents and electors of Miami-Dade County unless this Board, by a two-thirds vote of its full membership, waives this requirement; and

WHEREAS, this Board would like to waive such residency requirement for Arthur Rosenberg, who will be moving from Miami-Dade to Broward County; and

WHEREAS, an engaged member of the community, Mr. Rosenberg currently serves as the chair of the Living Wage Commission and has been a member of the Commission for the past 17 years; and

WHEREAS, Mr. Rosenberg possesses the knowledge and skills that have allowed and will continue to allow him to contribute to the Living Wage Commission; and

WHEREAS, Mr. Rosenberg is a senior attorney at Florida Legal Services where he practices law reform litigation in the areas of homelessness, consumer law, employment, and housing; and

WHEREAS, a copy of Mr. Rosenberg's resume is attached hereto as Attachment A; and

WHEREAS, this Board desires to waive the residency requirement of section 2-11.38 of the Code of Miami-Dade County, Florida for Arthur Rosenberg, board member of the Miami-Dade County Living Wage Commission, until the end of his term in November 2022,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Ratifies and adopts the matters set forth in the foregoing recitals. Section 1.

By a two-thirds vote of its full membership, pursuant to section 2-11.38 of Section 2. the Code of Miami-Dade County, waives the residency requirement for Arthur Rosenberg, board member of the Miami-Dade County Living Wage Commission, until the end of his term in November 2022.

The Prime Sponsor of the foregoing resolution is Commissioner Jose "Pepe" Diaz. It was offered by Commissioner , who moved its adoption. The motion was seconded by Commissioner and upon being put to a vote, the vote was as follows:
