### **Recommendation**

It is recommended that the Board of County Commissioners (Board) adopt the attached resolution approving the Midtown Miami Community Redevelopment Agency's (Agency) FY 2019-20 budget for the Midtown Miami Community Redevelopment Area (Area) in the amount of \$8,883,704.

The Interlocal Cooperation Agreement (Interlocal) between Miami-Dade County (County), the City of Miami (City), and the Agency requires the Agency submit an annual budget for County approval, but does not require Board approval prior to expending funds on budgeted activities.

#### Scope of Agenda Item

The Area lies within County Commission District 3, which is represented by Chairwoman Audrey M. Edmonson.

### Fiscal Impact / Funding Source

The Agency's revenue source is tax increment financing (TIF), which is generated through the incremental growth of ad valorem revenues beyond an established base year, as defined in section 163.387, Florida Statutes. For FY 2019-20, the Countywide TIF payment into the Agency's Trust Fund is \$3,388,946, and the City's TIF payment into the Trust Fund is \$5,494,758.

The County will continue to make annual payments to the Agency, based on each respective year's growth of ad valorem revenues over the base year through 2037 when the Agency and the Area will sunset.

#### Track Record / Monitor

This resolution does not provide for contracting with any specific entity. The resolution approves the Agency's FY 2019-20 budget.

# Background

On March 1, 2005, the Board adopted Resolution No. R-213-05, which established the boundaries of the Area and declared the Area to be slum or blighted. On June 7, 2005, the Board approved the establishment of the Agency by adopting the Agency's Community Redevelopment Plan (Plan) and funding of the Agency's Redevelopment Trust Fund through the adoption of Ordinance No. 05-108. The Interlocal and First Amendment to the Plan was approved by the Board on July 7, 2005 when it adopted Resolution No. R-626-05. The Interlocal requires the Agency to submit an annual budget for County approval.

On July 17, 2008, the Board adopted Resolution No. R-840-08, which approved the Second Amendment to the Interlocal. This amendment removed the requirement that the Midtown Miami Project must obtain a certain number of certificates of occupancy prior to the Agency funding the Midtown Miami Development District (District). This change also allowed the Agency to make payments to the District for debt service on the parking garage and public plaza that were completed.

# FY 2019-20 Budget

The Agency's FY 2019-20 budget of \$8,883,704 was approved by the both Agency (MCRA-R-19-0001) and the City (R-19-0364) on September 12, 2019. The budget includes revenue sources of County and City TIF of \$3,388,946 and \$5,494,758, respectively. Administrative expenditures total \$88,837. In accordance with the Second Amendment to the Interlocal, these expenses represent one percent of the total tax increment revenues.

Operating expenditures total \$8,794,867 and consist entirely of a transfer to the District to pay for annual debt service payments on the 2004A series bonds issued for the parking garage structure in the Midtown Miami development. This expenditure is detailed in Exhibit 1 to the attached resolution.

A RESOLUTION OF THE MIAMI CITY COMMISSION, WITH ATTACHMENT(S), ACCEPTING AND APPROVING THE PROPOSED BUDGET OF THE MIDTOWN COMMUNITY REDEVELOPMENT AGENCY, ATTACHED AND INCORPORATED AS COMPOSITE EXHIBIT "A," IN THE AMOUNT OF \$8,883,704.00, FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2019 AND ENDING SEPTEMBER 30, 2020, AS APPROVED BY THE MIDTOWN CRA'S BOARD OF COMMISSIONERS.

WHEREAS, on April 29, 2004, the City Commission adopted Resolution No. 04-0288 authorizing the City of Miami ("City"), Miami-Dade County ("County"), and the Midtown Miami Community Development District ("District") to undertake certain subsequent legal measures in accordance with the Community Redevelopment Act of 1969, as amended, under Chapter 163, Part III, Florida Statutes ("CRA Act") and to enter into an interlocal agreement creating the Midtown Community Redevelopment Agency ("Midtown CRA") within the District under certain conditions to be fulfilled by the District in connection with its intent to Issue special assessment bonds for certain capital improvements; and

WHEREAS, on March 1, 2005, the Board of County Commissioners of Miami-Dade County ("County Commission") approved Resolution No. 213-05 ("County Authorizing Resolution") adopting a Finding of Necessity and finding that the Midtown Redevelopment Area ("Midtown Area") was qualified under the conditions of the CRA Act for creation of the Midtown CRA and delegated to the City Commission the authority to create the Midtown CRA for the Midtown Area; and

WHEREAS, on March 24, 2005, the City Commission adopted Resolution No.05-0194 creating the Midtown CRA and on May 26, 2005, adopted Resolution No. 05-0344 authorizing the City Manager to execute the First Amendment to the Original Interlocal Agreement ("First Amendment") among the City, the County, the District, and the newly created Midtown CRA; and

WHEREAS, as of June 30, 2005, the City, the County, the District, and the Midtown CRA entered into the First Amendment; and

WHEREAS, subsequently, as of September 23, 2008, the City, the County, the District, and the Midtown CRA entered into a Second Amendment to the Original Interlocal Agreement ("Second Amendment"); and

WHEREAS, the Original Interlocal Agreement, as amended by the First Amendment and the Second Amendment (collectively, "Interlocal Agreement"), requires the Midtown CRA to submit its annual budget for approvals by the City Commission and the County Commission; and

WHEREAS, on September 12, 2019, the Board of Commissioners of the Midtown CRA approved and adopted the Midtown CRA's Proposed Budget for the fiscal year commencing October 1, 2019 and ending September 30, 2020 in the amount of \$8,883,704.00 through

Resolution No. MCRA-R-19-0001, attached and incorporated as part of Composite Exhibit "A"; and

WHEREAS, the Board of Commissioners of the Midtown CRA requests the City Commission to approve and adopt the Midtown CRA's proposed budget for the fiscal year commencing October 1, 2019 and ending September 30, 2020, attached and incorporated in Composite Exhibit "A";

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF MIAMI, FLORIDA:

Section 1. The recitals and findings contained in the Preamble to this Resolution are approved by reference and incorporated as if fully set forth in this Section.

Section 2. The proposed budget of the Midtown CRA, attached and incorporated as Composite Exhibit "A," in the amount of \$8,883,704.00 for the fiscal year commencing October 1, 2019 and ending September 30, 2020 as approved by the Midtown CRA's Board of Commissioners is accepted and approved.

Section 3. This Resolution shall become effective immediately upon its adoption.<sup>1</sup>
