Resolution Approving the Plat of Silver Palms Midtown Filed by Lennar Homes, LLC

<u>Recommendation</u>

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Silver Palms Midtown is bounded on the north by SW 236 Street, on the east by SW 115 Avenue, on the south approximately 135 feet north of SW 238 Street, and on the west by SW 117 Avenue.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

<u>Scope</u>

This plat is located in Commission District 8, which is represented by Commissioner Daniella Levine Cava.

Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the County would be approximately \$1,300.00 annually for new roadway construction adjacent to and within the project. These costs would be covered by the Department of Transportation and Public Works' annual General Fund allocation.

The Development Services Division of the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.


