Resolution Approving the Plat of Eureka Cove Filed by 13256 Investments, LLC

Recommendation

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Eureka Cove bounded on the north by SW 176 Street, on the east approximately 80 feet west of SW 114 Avenue, on the south approximately 130 feet north of SW 180 Street, and on the west by the Homestead Extension of Florida's Turnpike.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

<u>Scope</u>

This plat is located in Commission District 9, which is represented by Commissioner Dennis C. Moss.

Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the County would be approximately \$50.00 annually for new roadway construction adjacent to the project. These costs would be covered by the Department of Transportation and Public Works' annual General Fund allocation.

The Development Services Division of the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.



RESOLUTION APPROVING THE PLAT OF EUREKA COVE FILED BY 13256 INVESTMENTS, LLC, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 31, TOWNSHIP 55 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY SW 176 STREET, ON THE EAST APPROXIMATELY 80 FEET WEST OF SW 114 AVENUE, ON THE SOUTH APPROXIMATELY 130 FEET NORTH OF SW 180 STREET, AND ON THE WEST BY THE HOMESTEAD EXTENSION OF FLORIDA'S TURNPIKE)
