

RESOLUTION CONDEMNING THE COMMENTS OF UNITED STATES SENATOR BERNIE SANDERS REGARDING COMMUNIST DICTATOR FIDEL CASTRO

**WHEREAS**, on a February 23, 2020 “60 Minutes” interview, United States Senator and presidential candidate Bernie Sanders refused to condemn the communist dictatorship of Fidel Castro in Cuba; and

**WHEREAS**, as part of his comments, Senator Sanders expressed support for a “massive literacy program” that Senator Sanders ascribed to the Castro regime; and

**WHEREAS**, on February 24, 2020, Senator Sanders defended his remarks during a televised town hall in Charleston, South Carolina; and

**WHEREAS**, on February 25, 2020, Senator Sanders again insisted that “Cuba made progress on education” under Fidel Castro and stated that “when dictatorships, whether it is the Chinese or the Cubans do something good, you acknowledge that”; and

**WHEREAS**, Miami-Dade County is home to the largest number of Cubans and Cuban-Americans in the United States, many of whom fled the repressive, communist dictatorship imposed by Fidel Castro; and

**WHEREAS**, as described in a recent article by Fabiola Santiago in the Miami Herald, the literacy program that Senator Sanders ascribed to Fidel Castro not only predated Castro but also became an indoctrination program under Castro; and

**WHEREAS**, Fidel Castro and the Communist Party of Cuba blocked access to independent sources of information and imposed outright censorship of books, libraries, and educational sources; and

**WHEREAS**, Cubans who resisted communist indoctrination by Fidel Castro and his regime risked human rights abuses including violence, imprisonment, and execution; and

**WHEREAS**, by the early 1960s Fidel Castro held as many as 60,000 political prisoners; and

**WHEREAS**, killings ordered by Fidel Castro are estimated to be as high as 17,000; and

**WHEREAS**, the Cuban dictatorship first imposed by Fidel Castro continues today under Raul Castro and his puppet, Miguel Diaz-Canel, and continues to be responsible for systemic human rights abuses, and a lack of basic freedoms of press, religion, assembly, and association; and

**WHEREAS**, this Board condemns the comments by Senator Sanders, and wishes to promote all measures designed to educate the public regarding the horrors of the Castro regime,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board condemns the comments of United States Senator Bernie Sanders regarding communist dictator Fidel Castro, which misrepresent the nature of the supposed literacy program under the Castro regime, and which further disregard the history of systemic human rights abuses and forced indoctrination of that regime.

The Prime Sponsor of the foregoing resolution is Commissioner Jose "Pepe" Diaz. It was offered by Commissioner \_\_\_\_\_, who moved its adoption. The motion was seconded by Commissioner \_\_\_\_\_ and upon being put to a vote, the vote was as follows:
