

RESOLUTION ESTABLISHING COUNTY POLICY REQUIRING HAITIAN CREOLE, SPANISH, AND SIGN LANGUAGE INTERPRETERS AT COUNTYWIDE EMERGENCY ANNOUNCEMENTS AND EMERGENCY PRESS CONFERENCES FOR CORONAVIRUS DISEASE 2019 (COVID-19) AND FUTURE EMERGENCY SITUATIONS; DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO IDENTIFY AND DESIGNATE FUNDS THAT MAY BE USED IN THE CURRENT FISCAL YEAR TO SUPPORT THIS POLICY FOR ALL UPCOMING EMERGENCY ANNOUNCEMENTS AND EMERGENCY PRESS CONFERENCES AND FURTHER TO IDENTIFY AND DESIGNATE FUNDS TO SUPPORT THIS POLICY IN THE PROPOSED FISCAL YEAR 2020-2021 COUNTY BUDGET AND FUTURE BUDGETS

WHEREAS, Miami-Dade County ("the County") is home to a multi-ethnic community, and 70 percent of County residents speak a primary language other than English; and

WHEREAS, the Haitian Creole, English, and Spanish languages are deeply rooted in the historical and current culture of the County; and

WHEREAS, the County either employs or has contracts with Spanish and Haitian Creole translators and sign language interpreters; and

WHEREAS, during emergency situations, the County broadcasts vital information to County residents for their health, safety, and welfare; and

WHEREAS, providing such information in Haitian Creole, English, and Spanish, as well as sign language, will aid in the dissemination of vital information throughout the County in an easily accessible and understandable format,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. It is the policy of this Board that the County shall have Haitian Creole, Spanish, and sign language interpreters at countywide emergency announcements and emergency press conferences for coronavirus disease 2019 (COVID-19) and future emergency situations.

Section 2. This Board directs the County Mayor or County Mayor's designee to identify and designate legally available funds that may be used in the current fiscal year to support this policy for all upcoming emergency announcements and emergency press conferences and further to identify and designate funds to support this policy in the Proposed Fiscal Year 2020-2021 County Budget and future fiscal year budgets.

The Prime Sponsor of the foregoing resolution is Commissioner Jean Monestime. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:


