RESOLUTION NO.

RESOLUTION URGING THE FLORIDA LEGISLATURE AND GOVERNOR RON DESANTIS TO PROVIDE EMERGENCY ASSISTANCE FOR FLORIDA HOSPITALITY WORKERS IMPACTED BY HOTEL, RESTAURANT AND OTHER CLOSURES RELATED TO CORONAVIRUS 2019 (COVID-19) BY PROVIDING EMERGENCY SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM BENEFITS AND ASSISTANCE WITH QUALIFYING FOR AND RECEIVING UNEMPLOYMENT BENEFITS

WHEREAS, on January 31, 2020, United States President Donald Trump signed a proclamation barring entry into the United States of most foreign nationals who traveled to China within a specified time period; and

WHEREAS, on February 29, 2020, President Trump signed a proclamation that expanded travel restrictions to include all aliens who were physically present in the Islamic Republic of Iran during a specified period; and

WHEREAS, on March 11, 2020, the World Health Organization ("WHO") determined

that the coronavirus disease 2019 ("COVID-19") outbreak constitutes a pandemic; and

WHEREAS, on March 11, 2020, President Trump signed a proclamation restricting travel

to the United States for European foreign nationals in the Schengen zone; and

WHEREAS, on March 12, 2020, Walt Disney World, Universal Orlando and several other Florida amusement parks announced closures through the end of March 2020 due to COVID-19; and WHEREAS, on March 12, 2020, Miami-Dade County Mayor Gimenez declared a state of emergency in Miami-Dade County and suspended all operations at the American Airlines Arena, the Miami Open tennis tournament and other mass gatherings; and

WHEREAS, on March 13, 2020, President Trump declared a national emergency concerning the COVID-19 pandemic; and

WHEREAS, although the CDC has not recommended limiting domestic travel, on March 14, 2020, President Trump advised that he is considering domestic travel restrictions due to COVID-19; and

WHEREAS, Visit Florida, the state's official tourism marketing corporation, estimates that Florida welcomed 127 million visitors in 2018; and

WHEREAS, according to Visit Florida, visitors to Florida contributed \$85.9 billion to Florida's economy and supported 1.5 million Florida jobs in 2017; and

WHEREAS, the Greater Miami Convention & Visitors Bureau reported 23.3 million visitors to Miami in 2018 and reported that the travel and hospitality sector employed a record 142,100 people in 2018; and

WHEREAS, hospitality workers that have contributed to Florida's tourism economy will likely face unprecedented unemployment as tourism decreases and mass gatherings are prohibited during the COVID-19 pandemic; and

WHEREAS, in order to ensure a safe and healthy Florida, it is essential that Florida hospitality workers who become unemployed as a result of COVID-19 receive unemployment benefits without delay and are permitted swift access to healthy food options; and

WHEREAS, this Board urges the Florida Legislature and Governor Ron DeSantis to enact measures to provide Florida hospitality workers who become unemployed with emergency Supplemental Nutrition Assistance Program benefits, also known as SNAP benefits, and assistance with qualifying for and receiving unemployment benefits,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

<u>Section 1.</u> Urges the Florida Legislature and Governor Ron DeSantis to provide emergency assistance for Florida hospitality workers impacted by hotel, restaurant and other closures related to Coronavirus COVID-19 by providing emergency supplemental nutrition assistance program benefits and assistance with qualifying for and receiving unemployment benefits.

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Governor, Senate President, House Speaker and the Chair and Members of the Miami-Dade Legislative Delegation.

Section 3. Directs the County's lobbyist to advocate for the legislative action set forth in section 1 above and authorizes and directs the Office of Intergovernmental Affairs to amend the 2020 State Legislative Package to include this item and to include this item in the 2021 State Legislative Package when it is presented to the Board.

The Prime Sponsor of the foregoing resolution is Commissioner Jean Monestime. It was offered by Commissioner , who moved its adoption. The motion was seconded by Commissioner and upon being put to a vote, the vote was as follows:
