# **Recommendation**

It is recommended that the Board of County Commissioners approve this request for award of Designated Purchase Contract No. BW-10067, Acquisition of Lost and Found Items at Miami International Airport (MIA) to Goodwill Industries of South Florida, Inc. (Goodwill) for the Miami-Dade Aviation Department (MDAD). The Contract provides for the purchase, pick-up, and transport of lost and found items from MIA's Lost and Found facility. Approval of this designated purchase is being requested pursuant to Section 2-8.1(b)(3) of the Miami-Dade County Code, which provides for such purchases when no competition exists.

MDAD is seeking to enter into a contract with a Not-for-Profit Organization (NPO) who pays the County a monthly fee for unclaimed items after they have been examined by MDAD. In an attempt to reach additional vendors, Request for Information (RFI -01386) was issued on Bidsync. A total of 24,750 vendors were invited to respond to the RFI of which 71 reviewed it. Competition for these services is not practicable because Goodwill is the only vendor that meets both requirements at this time based on the County's market research.

Goodwill has agreed to pay the County a monthly amount of \$13,000. Goodwill will continue to use the proceeds from the sale of these items for charitable purposes to benefit Miami-Dade County residents.

# Scope

The scope of this item is countywide in nature.

# Fiscal Impact/Funding Source

The fiscal impact for the five-year term is \$780,000 in revenue to the County. The current contract, RFP-MDAD-06-12, generated approximately \$909,090 in revenue for a seven-year and six- month term, and expires on May 26, 2020.
