

SUBJECT: Resolution directing the County Mayor to (1) develop a plan to implement a voluntary cardiopulmonary resuscitation (“CPR”) training program by December 2020 for all County employees; (2) examine whether it is feasible for County employees, such as Miami-Dade Fire Rescue Department personnel, to provide the CPR training; (3) display a commemorative plaque in honor of Laronda Marshall in a Metrobus; (4) identify available funding sources from within the fiscal year 2019-2020 County budget for the CPR training program and the commemorative plaque should said occur within this fiscal year; (5) include the implementation of said CPR training program and commemorative plaque, as necessary, in the Mayor’s Proposed Budget for fiscal year 2020-2021 submitted to this Board for approval; and (6) provide a report within a specified time

RESOLUTION NO. _____

RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO (1) DEVELOP A PLAN TO IMPLEMENT A VOLUNTARY CARDIOPULMONARY RESUSCITATION ("CPR") TRAINING PROGRAM BY DECEMBER 2020 FOR ALL COUNTY EMPLOYEES; (2) EXAMINE WHETHER IT IS FEASIBLE FOR COUNTY EMPLOYEES, SUCH AS MIAMI-DADE FIRE RESCUE DEPARTMENT PERSONNEL, TO PROVIDE THE CPR TRAINING; (3) DISPLAY A COMMEMORATIVE PLAQUE IN HONOR OF LARONDA MARSHALL IN A METROBUS; (4) IDENTIFY AVAILABLE FUNDING SOURCES FROM WITHIN THE FISCAL YEAR 2019-2020 COUNTY BUDGET FOR THE CPR TRAINING PROGRAM AND THE COMMEMORATIVE PLAQUE SHOULD SAID OCCUR WITHIN THIS FISCAL YEAR; (5) INCLUDE THE IMPLEMENTATION OF SAID CPR TRAINING PROGRAM AND COMMEMORATIVE PLAQUE, AS NECESSARY, IN THE MAYOR'S PROPOSED BUDGET FOR FISCAL YEAR 2020-2021 SUBMITTED TO THIS BOARD FOR APPROVAL; AND (6) PROVIDE A REPORT WITHIN A SPECIFIED TIME

WHEREAS, on September 19, 2019, Laronda Marshall, a Miami-Dade County Metrobus operator, was in the midst of her bus route when a passenger told her a man in the bus was slumped over and seemed ill; and

WHEREAS, Ms. Marshall quickly parked the bus and headed to assist the passenger in need; and

WHEREAS, the passenger was unconscious and nonresponsive, and Ms. Marshall could not feel his pulse; and

WHEREAS, Ms. Marshall, who is a former nurse's aide, asked another passenger to dial 911, as she started steady chest compressions on the unresponsive passenger; and

WHEREAS, Ms. Marshall continued to administer cardiopulmonary resuscitation (“CPR”) and was able to get the passenger to begin breathing again by the time fire rescue arrived on the scene; and

WHEREAS, Ms. Marshall’s heroic actions of performing CPR while fire rescue arrived on scene likely saved the passenger’s life; and

WHEREAS, Ms. Marshall’s story demonstrates that all County employees, especially Metrobus and Metrorail operators, should have the opportunity to receive CPR training on a voluntary basis, as they are in the best position to administer immediate life-saving assistance in the case of an emergency at a County facility or on a Metrobus or Metrorail vehicle,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. This Board directs the County Mayor or County Mayor’s designee (1) to develop a plan by December 2020 to implement a voluntary CPR training program, to be called the “Laronda Marshall CPR Training Program,” for all County employees, (2) to examine whether it is feasible for County employees, such as Miami-Dade Fire Rescue Department personnel, to provide the CPR training for the Laronda Marshall CPR Training Program, and (3) to display a commemorative plaque in honor of Laronda Marshall inside the Metrobus that Ms. Marshall was operating on September 19, 2019 or inside a Metrobus that is assigned to the route that Ms. Marshall was operating on September 19, 2019.

Section 2. This Board further directs the County Mayor or County Mayor’s designee to identify available funding sources from within the fiscal year 2019-2020 County Budget that independently or combined may be utilized to fund the implementation of the voluntary CPR training program and placement of the commemorative plaque identified in Section 1 above should

said implementation occur within the 2019-2020 fiscal year, and to include the implementation of said voluntary CPR training program and placement of commemorative plaque, as necessary, in the Mayor's Proposed Budget for fiscal year 2020-2021 submitted to this Board for approval.

Section 3. The County Mayor or County Mayor's designee shall, within 90 days of the effective date of this resolution, provide to this Board a report describing the steps taken to comply with Sections 1 and 2 above and shall place the completed report on an agenda of the Board pursuant to Ordinance No. 14-65.

The Prime Sponsor of the foregoing resolution is Commissioner Esteban L. Bovo, Jr. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:


