RESOLUTION NO. _____

RESOLUTION DIRECTING THE COUNTY MAYOR TO TAKE
MEASURES TO REDUCE WATER LEVELS IN SECONDARY
CANALS AS APPROPRIATE FOR HURRICANE SEASON,
AND TO PROVIDE A REPORT

WHEREAS, a system of primary, secondary, and tertiary canals stretches across Miami-Dade County; and

WHEREAS, Miami-Dade County is responsible for the maintenance of approximately 168 miles of secondary canals, including control of aquatic weeds and woody vegetation; inspection, maintenance, and cleaning of culverts; and removal of floating debris and other obstructions; and

WHEREAS, one of the main purposes of the secondary canal system is to provide flood protection to the people and businesses of Miami-Dade County; and

WHEREAS, due to its unique geography and geology, Miami-Dade County is susceptible to flooding from major rain events and storm surge, particularly during hurricane season, which lasts every year from June 1 until November 30; and

WHEREAS, the County's secondary canal system may provide flood protection during hurricane season, and the systems must be in proper condition to best handle an influx of heavy rainfall; and

WHEREAS, for example, secondary canal levels must be properly set to accommodate heavy rainfall; and

WHEREAS, because hurricane season has already begun, this Board wishes to direct the County Mayor to take measures to reduce water levels in secondary canals as appropriate for hurricane season,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board directs the County Mayor to take measures to reduce water levels in secondary canals as appropriate for hurricane season, and to prepare a report summarizing the actions taken to comply with the directives of this resolution. The County Mayor shall provide the report to this Board within 30 days of the effective date of this resolution and shall place the completed report on an agenda of the Board pursuant to Ordinance No. 14-65.

The Prime Sponsor of the foregoing resolution is Commissioner Joe A. Martinez. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:


