RESOLUTION RENAMING “WEST DADE REGIONAL LIBRARY” AS “WESTCHESTER REGIONAL LIBRARY”

**WHEREAS**, “West Dade Regional Library” is located within unincorporated Miami-Dade County at 9455 Coral Way; and

**WHEREAS**, Westchester is a neighborhood in unincorporated Miami-Dade County with its own unique charm and identity; and

**WHEREAS**, adjacent to the “West Dade Regional Library” ~~[[there is a recently built]]~~<sup>1</sup> >>groundbreaking has occurred for a<< County facility named the Westchester Library Health and Wellness Information Center; and

**WHEREAS**, renaming “West Dade Regional Library” to “Westchester Regional Library” would provide for unity and consistency of the two County buildings, and would strengthen the neighborhood identity of Westchester; and

**WHEREAS**, Rule 9.02 of the Board’s Rules of Procedure provides that resolutions regarding the proposed naming, renaming, or codesignation of Miami-Dade County roads, facilities or property shall be sponsored by the district commissioner where the road, facility, or property is located; and

**WHEREAS**, “West Dade Regional Library” is located in County Commission District 10, represented by Senator Javier D. Souto,
