Report of Financial Relief provided to Certain Vendors Leasing Space in County Facilities -

Directive No. 200906

On May 19, 2020, the Board of County Commissioners (Board) approved Resolution No. R-506-20, directing the County Mayor or the County Mayor's designee to develop and implement a financial relief plan for certain vendors operating in County facilities, which have been adversely impacted by the coronavirus disease (COVID-19), if fiscally advisable, and within legally available means. The 16 identified vendors operate in 11 County-owned buildings and one vendor operates on vacant County-owned property.

In June 2020, the Internal Services Department communicated with each retail tenant to notify them of the opportunity to temporarily waive or reduce rent payments, or other financial obligations, due to Miami-Dade County. The Department also requested supporting documentation, which would establish a need for a waiver or reduction in rent in the form of gross receipts (both before and after March 2020) or other evidence which demonstrates a hardship for the tenant.

To date, seven tenants have responded to the Department, and have provided the necessary supporting documentation warranting financial relief. The Department has notified these tenants that their request for a waiver or reduction in rent has been approved. The amount of rent which has been waived, beginning April 1, 2020 and ending September 30, 2020, totals approximately \$95,748. The total amount is an approximation because some of the Lease Agreements with tenants require them to pay a percentage of their sales as rent. The total includes an estimated amount that the County would have received from those tenants based upon previous sales.

The Department continues its efforts to follow up with the remaining nine tenants to obtain the appropriate documentation, or to remind them of the opportunity extended by the County to receive financial relief.

This report has been transmitted to the Office of Management and Budget and will be placed on the next available agenda pursuant to Ordinance 14-65.
