

Subject: Resolution Retroactively Authorizing the County Mayor to Apply For, Receive and Expend \$1,000,000.00 in Federal Grant Funds from the United States Department of Homeland Security Port Security Grant Program During the Fiscal Year of 2020-2021

Agenda Item No. 3(B)(1)

RECOMMENDATION

It is recommended that the Board of County Commissioners (Board) approve the attached resolution retroactively authorizing the County Mayor or County Mayor’s designee to apply for, receive and expend approximately \$1,000,000 in federal funds from the United States Department of Homeland Security Port Security Grant Program during Fiscal Year (FY) 2020 - 2021. This grant agreement is awarded to Miami-Dade County by and through the Miami-Dade Fire Rescue (MDFR) Department to provide port-wide maritime security risk management; enhance maritime domain awareness; and to maintain or re-establish maritime security mitigation protocols that support port recovery and resiliency capabilities. The performance period is from September 1, 2020 through August 31, 2023. This agreement requires retroactive approval since the award was received electronically on August 27, 2020.

SCOPE

The grant will provide countywide services.

FISCAL IMPACT/FUNDING SOURCE

This grant will provide federal funding of \$1,000,000. from the U.S. Department of Homeland Security during FY 2020-2021 upon approval from the Board. The required matching local contribution of \$333,334 will be budgeted in Fiscal Year 2021-2022.

DELEGATION OF AUTHORITY

The County Mayor or County Mayor’s designee is authorized to apply for, receive, and expend grant funds, and execute related documents to implement the grant program, which may be required by grant guidelines or to further the purpose described in the funding request. Also, the County Mayor or County Mayor’s designee is authorized to execute any necessary amendments and/or modifications to the application documents that relate to receiving grant funds.

TRACK RECORD/MONITOR

The grant award will be monitored by Lisset Elliott, Grants Manager for MDFR.

BACKGROUND

The Port Security Grant Program is one tool in the comprehensive set of measures authorized by Congress and implemented by the Administration to strengthen the Nation’s critical infrastructure against risks associated with potential terrorist attacks. The 2020 Port Security Grant Program provides funds for transportation infrastructure security activities to implement Area Maritime Security Plans and facility security plans among port authorities, facility operators, and state and local government agencies required to provide port security services.

The Port Security Grant Program plays an important role in the implementation of the National Preparedness System by supporting the building, sustainment, and delivery of core capabilities essential to achieving the National Preparedness Goal (the Goal) of a secure and resilient nation. The allowable costs support efforts to build and sustain core capabilities across the prevention, protection, mitigation, response, and recovery mission areas.

MDFR has the responsibility to provide fire protection and rescue emergency response to PortMiami. MDFR was awarded federal funding to purchase a Watercraft-all hazards CBRNE/IED Vessel. CBRNE all hazards Port Security Vessel with permanently mounted Radiation/Chemical/IED Detection Systems, Side Scan Sonar, Forward Looking Infrared (FLIR). Global Positioning System (GPS), and Spectra Max Lighting system. The vessel shall be equipped with the latest in Hazardous Materials detection mounted system, and will also be staffed with crews that are dually certified in hazard responses, mitigation, and recovery efforts. The vessel shall be staffed with Paramedics, Drivers and NASBLA SAR certified employees. The new vessel shall be 50 feet in length and will be equipped with the latest technology to aid in early detection and prevention efforts enhancing the resiliency of South Florida and the Captain of the Port zone.

These assets will support the Area Maritime Security Plan by strengthening the areas resiliency and by reducing security gaps and deficiencies within Sector Miami.

RESOLUTION RETROACTIVELY AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO APPLY FOR, RECEIVE AND EXPEND \$1,000,000.00 IN GRANT FUNDS FROM THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY PORT SECURITY GRANT PROGRAM AND TO CONTRIBUTE \$333,334.00 IN MATCHING FUNDS FROM THE FIRE DISTRICT FUNDS IN FISCAL YEAR 2021-2022; AND AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO APPLY FOR, RECEIVE, AND EXPEND ADDITIONAL FUNDS SHOULD THEY BECOME AVAILABLE UNDER THIS GRANT PROGRAM AND TO EXERCISE ANY OF THE TERMS CONTAINED HEREIN

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board authorizes the County Mayor or County Mayor's designee to: (1) retroactively apply for, receive, and expend Port Security Grant Program funds in the amount of \$1,000,000.00 from the United States Homeland Security Department, in substantially the form attached hereto as Exhibit A, to provide port-wide maritime security risk management; enhance maritime domain awareness; and to maintain or re-establish maritime security mitigation protocols that support port security recovery and resiliency capabilities; (2) contribute \$333,334.00 in matching funds from the Fire District Funds in in Fiscal Year 2021-2022; (3) apply for, receive and expend future additional funds should they become available through the grant program performance period; and (4) to exercise any of the terms contained in the grant agreement documents.

Article I - Summary Description of Award

The terms of the approved Investment Justification(s) and Budget Detail Worksheet(s) submitted by the recipient are incorporated into the terms of this Federal award, subject to the additional description and limitations stated in this Agreement Article and the limitations stated in subsequent reviews by FEMA of the award budget. Investments not listed in this Agreement Article are not approved for funding under this award.

Investment 1: Watercraft-all hazards CBRNE/IED Vessel is fully funded for \$1000000.

Article II - Activities Conducted Abroad

Recipients must ensure that project activities carried on outside the United States are coordinated as necessary with appropriate government authorities and that appropriate licenses, permits, or approvals are obtained.

Article III - Reporting of Matters Related to Recipient Integrity and Performance

If the total value of any currently active grants, cooperative agreements, and procurement contracts from all federal awarding agencies exceeds \$10,000,000 for any period of time during the period of performance of this federal award, then the recipients must comply with the requirements set forth in the government-wide Award Term and Condition for Recipient Integrity and Performance Matters located at 2 C.F.R. Part 200, Appendix XII, the full text of which is incorporated here by reference in the award terms and conditions.

Article IV - Trafficking Victims Protection Act of 2000 (TVPA)

Recipients must comply with the requirements of the government-wide financial assistance award term which implements Section 106(g) of the Trafficking Victims Protection Act of 2000 (TVPA), codified as amended at 22 U.S.C. section 7104. These regulations restrict federal financial assistance awards, subawards, and contracts with certain parties that are debarred, suspended, or otherwise excluded from or ineligible for participation in federal assistance programs or activities.

Article VII - Fly America Act of 1974

No. 101-336 (1990) (codified as amended at 42 U.S.C. sections 12101-12213), which prohibits recipients from discriminating on the basis of disability in the operation of public entities, public and private transportation systems, places of public accommodation, and certain testing entities.

Article IX - Duplication of Benefits

Any cost allocable to a particular federal financial assistance award provided for in 2 C.F.R. Part 200, Subpart E may not be charged to other federal financial assistance awards to overcome fund deficiencies; to avoid restrictions imposed by federal statutes, regulations, or federal financial assistance award terms and conditions; or for other reasons. However, these prohibitions would not preclude recipients from shifting costs that are allowable under two or more awards in accordance with existing federal statutes, regulations, or the federal financial assistance award terms and conditions.

Article X - Copyright

Recipients must affix the applicable copyright notices of 17 U.S.C. sections 401 or 402 and an acknowledgement of U.S. Government sponsorship (including the award number) to any work first produced under federal financial assistance awards.

Article XI - Civil Rights Act of 1968

Recipients must comply with Title VIII of the Civil Rights Act of 1968, Pub. L. No. 90-284, as amended through Pub. The prohibition on disability discrimination includes the requirement that new multifamily housing with four or more dwelling units-i.e., the public and common use areas and individual apartment units (all units in buildings with elevators and ground-floor units in buildings without elevators)-be designed and constructed with certain accessible features. Article XII - Best Practices for Collection and Use of Personally Identifiable Information (PII)

Recipients who collect PII are required to have a publicly available privacy policy that describes standards on the usage and maintenance of the PII they collect. Article XVIII - Procurement of Recovered Materials

States, political subdivisions of states, and their contractors must comply with Section 6002 of the Solid Waste Disposal Act, Pub. L. No. 89-272 (1965), (codified as amended by the Resource Conservation and Recovery Act, 42 U.S.C. section 6962.) The requirements of Section 6002 include procuring only items designated in guidelines of the Environmental Protection Agency (EPA) at 40 C.F.R. Part 247 that contain the highest percentage of recovered materials practicable, consistent with maintaining a satisfactory level of competition.

Article XIX - Terrorist Financing

Article XXIV - Rehabilitation Act of 1973

(See 31 U.S.C. sections 3801-3812, which details the administrative remedies for false claims and statements made.)

Article XXVI - Nondiscrimination in Matters Pertaining to Faith-Based Organizations
