RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO TAKE NECESSARY MEASURES TO **INCENTIVIZE INFLUENZA** VACCINATIONS; URGING (1)THE FLORIDA LEGISLATURE, GOVERNOR RON DESANTIS, AND THE FLORIDA DEPARTMENT OF HEALTH TO INCENTIVIZE INFLUENZA VACCINATION AND TO TAKE MEASURES TO SUFFICIENT ENSURE COUNTYWIDE SUPPLY OF INFLUENZA VACCINES FOR THE 2020-2021 INFLUENZA SEASON AND (2) THE SCHOOL BOARD OF MIAMI-DADE COUNTY TO INCENTIVIZE INFLUENZA VACCINATION. TO ASSIST AND SUPPORT THE COUNTY'S ONGOING **RESPONSE TO THE CORONAVIRUS DISEASE 2019 (COVID-19) PANDEMIC**

WHEREAS, every winter hundreds of different influenza virus strains emerge, infecting

people around the world; and

WHEREAS, on average the seasonal influenza kills 36,000 people every year in the

United States, with many of the deaths occurring during the winter months; and

WHEREAS, history is replete with outbreaks of widespread seasonal influenza, some with

far higher death tolls; and

WHEREAS, with the coronavirus disease 2019 (COVID-19) pandemic expected to

continue throughout the coming months, some experts fear an especially deadly winter season this

year; and

WHEREAS, the United States Centers for Disease Control and Prevention ("CDC") believes that it is likely that the influenza viruses and the virus that causes COVID-19 will be

spreading simultaneously during the winter months; and

WHEREAS, according to the CDC, given the convergence of the seasonal circulation of influenza viruses and the ongoing COVID-19 pandemic, receiving influenza vaccinations will be more important than ever this season; and

WHEREAS, because some of the symptoms of influenza and COVID-19 are similar, it may be difficult to confirm a diagnosis based on symptoms alone; and

WHEREAS, while most people need only one vaccine against some ailments, such as measles, to have life-long immunity, the influenza vaccine must be administered each year because there are numerous influenza viruses and they mutate frequently; and

WHEREAS, although influenza vaccines vary from year to year in their effectiveness, they cut the incidence, severity and transmission of the most common strains of the virus; and

WHEREAS, influenza vaccines have been shown to reduce the risk of illness, hospitalization and death caused by influenza; and

WHEREAS, the CDC advises that receiving an influenza vaccination will not only reduce risks associated with illness from influenza, but will also help to conserve potentially scarce health care resources; and

WHEREAS, the CDC recommends that all people six months and older get a yearly influenza vaccine; and

WHEREAS, according to the CDC, for the 2020-2021 season, manufacturers have projected they will provide as many as between 194 and 198 million doses of the influenza vaccine nationwide; and

WHEREAS, some settings which usually provide influenza vaccination, such as workplaces, may not offer vaccination during the upcoming season, because of challenges with maintaining social distancing; and

WHEREAS, given the CDC's advice that it will be more important than ever to get a vaccine for influenza this season, this Board emphasizes the need for vaccination incentives and measures to ensure maximum availability of influenza vaccine doses countywide; and

WHEREAS, this Board wishes to direct the County Mayor or County Mayor's designee to take necessary measures to incentivize influenza vaccinations; and

WHEREAS, this Board additionally urges the Florida Legislature, Governor Ron DeSantis and the Florida Department of Health to take necessary measures to incentivize influenza vaccinations and ensure a sufficient supply of influenza vaccination doses in Miami-Dade County; and

WHEREAS, this Board further urges the School Board of Miami-Dade County to take necessary measures to incentivize influenza vaccinations,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Directs the County Mayor or County Mayor's designee to take necessary measures to incentivize influenza vaccinations.

Section 2. Urges the Florida Legislature, Governor Ron DeSantis and the Florida Department of Health to take necessary measures to incentivize influenza vaccinations and ensure a sufficient supply of influenza vaccination doses in Miami-Dade County.

Section 3. Urges the School Board of Miami-Dade County to take necessary measures to incentivize influenza vaccinations.

Section 4. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Governor, Senate President, House Speaker, the Chair and Members of the Miami-Dade Legislative Delegation, the Florida Surgeon General, the Secretary for the Agency for Health Care

Administration, the Director of the Division of Emergency Management, the Chair and Members of the School Board of Miami-Dade County, and the Superintendent of Miami-Dade County Public Schools.

Section 5. Directs the County's lobbyist to advocate for the legislative action set forth in section 2 above and authorizes and directs the Office of Intergovernmental Affairs to amend the 2020 State Legislative Package to include this item, and to include this item in the 2021 State Legislative Package when it is presented to the Board.

The Prime Sponsor of the foregoing resolution is Commissioner Esteban L. Bovo, Jr. It was offered by Commissioner , who moved its adoption. The motion was seconded by Commissioner and upon being put to a vote, the vote was as follows:
