**Subject:** Recommendation for Approval to Exercise the Option to Renew Term under Legacy

Contract No. L9810-2/30, Flight Explorer Software Support Services

# **Recommendation**

It is recommended that the Board of County Commissioners (Board) authorize the County Mayor or County Mayor's designee to exercise the one, five-year option to renew under Contract No. L9810-2/30, Flight Explorer Software Support Services (Flight Explorer) for the Miami-Dade Aviation Department (MDAD). The initial five-year term was awarded to Sabre GLBL Inc. (Sabre), the sole proprietary owner of the software, under the County Mayor's delegated authority. Board approval is required as the value of the requested renewal brings the aggregate contract value over the County Mayor's delegated authority.

Flight Explorer is a vital tool for MDAD operations. This contract provides the department with continued use of Flight Explorer Professional Edition, which is used by Airside Operations as a tool to monitor all incoming and outgoing flights in real-time, and coordinate daily flight activities. It provides for global aircraft tracking with multiple data feeds, airport-specific alerts, dynamic weather overlays, and custom reporting. In addition to its daily operational utility, Flight Explorer is a critical tool during times of incremental weather and other emergencies requiring the immediate grounding of aircraft. Contract L-9810-2/30 was established to provide for the continued use of this proprietary system.

It should be noted that the tasks performed under the Federal Aviation Administration's Metroplex project, aimed at improving departure and arrival procedures and routes in the Terminal airspace, and Flight Explorer, which tracks the flight path of aircraft all over the world in the air, are mutually exclusive and do not impact one another.

The licensing, maintenance and support services provided by Sabre are not available through any other vendor. Staff has been conducting market research on an ongoing basis to determine if other vendors are available in the marketplace. There are other companies that provide flight tracking solutions; however, they cannot provide the required maintenance and support services for the existing system. Sabre is the system integrator, developer and owner of the proprietary software.

As a result, approval is being requested to exercise the one, five-year option to renew to continue purchasing the licensing, maintenance and support services, and avoid interruption for the use of the proprietary software provided by Sabre.

#### <u>Scope</u>

The scope of this item is countywide in nature.

#### **Fiscal Impact/Funding Source**

The initial contract term expires on December 31, 2020 and has a cumulative allocation of \$235,950. If this request is approved, the contract will have a modified cumulative allocation of \$441,675 and will expire December 31, 2025.

#### **Due Diligence**

Pursuant to Resolution No. R-187-12, due diligence was conducted in accordance with the Internal Services Department's Procurement Guidelines to determine contractor responsibility, including verifying corporate status and that there are no performance or compliance issues. The lists referenced included convicted vendors, debarred vendors, delinquent contractors, suspended vendors, and federal excluded parties. There were no adverse findings relating to contractor responsibility.

Pursuant to Resolution No. R-98-12, staff contacted the vendor to negotiate a reduction in pricing for the option to renew term. Those efforts resulted in the vendor offering reduced pricing, which results in a savings of \$8,775 during the OTR period.
