Subject: Miami International Airport (MIA) Retroactive Financial Relief Report -

November 2020

At the April 7, 2020 Board of County Commissioners (Board) meeting, Board members adopted Resolution No. R-332-20 as amended, approving a Retroactive Financial Relief Plan (Relief Plan) for airlines, concessionaires, car rental companies, cargo handlers, general aeronautical service permittees, fixed-base operators, and any other tenant providing services at Miami International Airport (MIA) including the aeronautical business operators at the General Aviation Airports (GAA) due to the steep decline in business revenues because of the "coronavirus disease 2019" (COVID-19) pandemic. This Relief Plan, which went into effect on April 18, 2020 complies with the guidelines published by the Federal Aviation Administration (FAA) in early April.

The Relief Plan, which was set to expire on August 31, 2020 was approved by Board members with an initial term of three months and a one-time three-month extension, subject to monthly reviews. Because business revenue levels continue to remain low throughout MIA and are forecasted to remain as such throughout the first quarter of this year, Board members extended the term of the Relief Plan for certain business partners at MIA two separate times. Each extension waives the Minimum Annual Guarantee (MAG) and/or rent on a month-to-month basis subject to monthly reviews for four consecutive months. The first extension approved at the July 21, 2020 Board meeting via Resolution No. R-749-20 granted an extension from September 1, 2020 to December 31, 2020 for 62 concessionaires and the only fixed-based operator at MIA required to pay a MAG, Signature Flight Support. The second extension approved at the December 15, 2020 Board meeting via Resolution No. R-1254-20 granted an extension from January 1, 2021 to April 30, 2021 for the same business partners included in the first extension in addition to Goodwill Industries of South Florida, Inc. By way of these extensions, the County is providing 64 business partners at MIA with the additional assistance needed to help sustain their businesses in light of the continued decrease in passenger traffic resulting from the ongoing pandemic.

The Miami-Dade Aviation Department (MDAD) has prepared its third monthly report for the third month of the first extension period, November 2020. The report provides data related to the financial relief offers made by the County to 62 MIA concessionaires and Signature Flight Support as well as updates on the changed financial circumstances due to the COVID-19 crisis.

First Extension of the Relief Plan

Per Resolution No. R-749-20, the Relief Plan for MIA's concessionaires and Signature Flight Support was extended for four continuous months beginning on September 1, 2020 and ending on December 31, 2020, subject to monthly reviews. A summary of the type of financial relief offered through the extension is as follows:

1) Waiver of monthly MAG payments, rent, and other related fees for dutyfree stores and any other concession operators contracted to pay MAG Honorable Chairman Jose "Pepe" Diaz and Members, Board of County Commissioners Page 2

monthly payment as well as monthly rent. Such waivers are effective on a month-to-month basis from September 1, 2020 to December 31, 2020 and are subject to monthly reviews. These concessionaires will continue to pay the assigned percentage fee of gross revenues in lieu of the MAG and rent for such time period.

2) Waiver of MAG monthly payments and other related fees for Signature Flight Support and all other concessionaires with MAG payments. Such waivers are effective on a month-to-month basis from September 1, 2020 to December 31, 2020 and are subject to monthly reviews. These concessionaires will continue to pay the assigned percentage fee of gross revenues in lieu of the MAG for such time period.

<u>Impacts of COVID-19 Pandemic</u>

In November 2020, the number of domestic air travelers rose more during the Thanksgiving holiday than the previous eight months as travelers around the country boarded planes for the long weekend. Passengers at domestic airport checkpoints totaled 1,176,091 on Sunday, November 29, 2020 according to the Transportation Security Administration (TSA), which is the highest number of screened passengers since March 2020 when the novel COVID-19 pandemic gutted travel demand. However, if compared to the number of passengers TSA screened at checkpoints on the same day in 2019, which totals 2,882,915 passengers, there is still a considerable drop of 59 percent on a year-to-year basis in the demand for air travel. Nonetheless, the Thanksgiving upward tick may be indicative of the start of a slow-climbing recovery nationwide, as evidenced by increases in airline ticket sales, in particular at MIA, where for the first time since mid-March 2020 the daily passenger count reached close to 75,000 passengers on November 29, 2020. More importantly, MIA's daily passenger counts continued to fluctuate throughout the month of December 2020 between a low of 50,000 passengers to a high of 80,000 passengers a day, which is a marked improvement from MIA passenger counts documented during the second and third quarters of 2020 that totaled between a low of almost 3,400 passengers to a high of approximately 28,000 passengers per day.

The level of passenger traffic flows and business revenues for the month of November 2020, which are the metrics being used to measure the demand for air travel at MIA are noted below with comparisons to the levels reported in 2019.

1. Passenger Traffic Flows at MIA

A comparative analysis of passenger traffic levels for the months of November 2019 and November 2020 shows an average decline in passenger flows (arrivals and departures) of 57.5 percent at MIA, with the total number of domestic and international passengers falling from 3,673,408 passengers to 1,561,783 passengers. A more detailed look at the analysis confirms that the number of domestic arrivals decreased by 49.2 percent, from 959,843 passengers to 487,957 passengers while the number of domestic departures dropped by 50.7 percent, from 935,669 passengers to 460,994 passengers. The number of international arrivals decreased by 67.4 percent, from 896,413 passengers to 292,369 passengers, whereas the number of international departures fell by more than 63.6 percent, from 881,483 passengers to 320,463 passengers.

On a cumulative basis, a comparative analysis of passenger traffic levels for March 2019, April 2019, May 2019, June 2019, July 2019, August 2019, September 2019, October 2019, and November 2019 as compared to the same months in 2020 shows an average decline in passenger flows (arrivals and departures) of 74.5 percent at MIA, with the total number of domestic and international passengers falling from 33,710,345 passengers to 8,597,516 passengers. Furthermore, the analysis confirms that the number of domestic arrivals decreased by 66.4 percent, from 8,592,027 passengers to 2,885,897 passengers while the number of domestic departures dropped by 65.8 percent, from 8,626,438 passengers to 2,947,883 passengers. The number of international arrivals decreased by 84.0 percent, from 8,400,311 passengers to 1,347,614 passengers, whereas the number of international departures fell by more than 82.5 percent, from 8,091,569 passengers to 1,416,122 passengers.

2. Gross Revenues Variance Analysis at MIA

A comparative analysis of total gross revenues for concessionaires for the months of November 2019 and November 2020 is represented in Chart A, as shown below. The analysis shows an average decline in total gross revenues of 64 percent, with revenues falling from \$39,582,377 to \$14,314,404 for concession operators contracted to pay MAG payments in addition to rent as well as for Signature Flight Support and concession operators whose MAG payments include rent.

On a cumulative basis, a comparative analysis of total gross revenues for concessionaires for March 2019, April 2019, May 2019, June 2019, July 2019, August 2019, September 2019, October 2019, and November 2019 as compared to the same months in 2020 shows an average decline in total gross revenues of 77 percent, with revenues falling from \$360,724,154 to \$82,010,466 for concession operators contracted to pay MAG payments in addition to rent as well as for Signature Flight Support and concession operators whose MAG payments include rent.

Chart C, as shown on the next page illustrates the total dollar amounts of relief provided by the County to concessionaires and Signature Flight Support at MIA for the month of November 2020 as well as the billed percentage fee from gross revenues. Each relief offer made and accepted or declined for the month of November 2020 is detailed on Attachment 1, as enclosed.
