The Board of County Commissioners’ approval of Ordinance No. 18-137 provided for the creation of 27 member Millennial Task Force to develop strategies to attract, retain and assist millennials in Miami-Dade County through, among other things, housing, career and transportation opportunities or incentives. The ordinance further provided that the Board, as a whole, appoint seven (7) at-large members to the Task Force of which two (2) seats are currently vacant.

The Clerk of the Board has received the name of Mr. Felipe Angulo, nominated by Commissioner Heyman, as a qualified candidate to fill one (1) of the vacant seats on the Millennial Task Force.
