Subject: Mayoral Appointment - Interim Director of Community Action and Human Services Department

Pursuant to the authority vested in me under Section 2.02(C) of the Miami-Dade County Home Rule Charter, I hereby appoint Annika Holder to the position of Interim Director of the Community Action and Human Services Department (CAHSD), effective immediately and until a permanent director is appointed.

Annika was initially appointed Interim Director of CAHSD on August 3, 2020 and is being reappointed in accordance with rule 8.1.02(i) of the Board's Rules of Procedure.

Annika began her career with Miami-Dade County in November 2016 as the Assistant Director of CAHSD. Among her many responsibilities in this role, she provided strategic leadership and oversight of social services initiatives and programs for the elderly, victims of domestic violence, sexual assault and human trafficking, veterans, court-involved and disconnected youth, migrant farmworkers, unemployed/under employed adults and low-income families. She managed the department's quality assurance, human resources, emergency planning and response, community participation and marketing/communication. She also oversaw the facility operations of 36 sites, including community and senior centers, emergency shelters and transitional housing, while working closely with various federal, state and local agencies to effectively manage more than \$30 million in grant-funded programming, and was responsible for the overall supervision of a staff of 275 employees.

Prior to joining the County, Annika served as the Assistant Deputy Commissioner of Educational Services for the City of New York. She has also held director-level roles with both the City of Atlanta and City of New York Parks and Recreation departments.

Annika has a master's degree in urban affairs and a bachelor's degree in psychology from the City University of New York. Her resume is attached for your review.

Annika has been instrumental in providing a broad range of much-needed services to the residents of Miami-Dade County throughout the COVID-19 pandemic, and I want to thank her for her ongoing leadership and service to our community. Please join me in congratulating Annika on her reappointment.
