Subject: Resolution Rejecting All Proposals Received for Capital Improvement Program

Specialized Services: ISD Project No. A18-MDAD-01

# **Background**

Miami-Dade County's Internal Services Department (ISD) is the second largest government procurement agency in the state of Florida and one of the largest municipal procurement agencies in the Southeast United States. The work of County procurement is critical to ensuring our public servants effectively use County resources to serve our diverse, growing population. I believe we need to look at County procurement processes and re-evaluate pending procurements with renewed commitment to our values, to ensure we are maximizing our purchasing power to its full potential and approaching procurement as a strategic opportunity for economic development.

To that end, as part of our overall effort to improve the County's procurement process, a replacement solicitation will be issued for ISD Project No. A18-MDAD-01. The replacement solicitation will enable us to maximize the County's purchasing power to better meet the needs of the County's growing and diverse population and businesses. The replacement solicitation will consider several criteria to help us become a more inclusive, stronger community for our residents and businesses:

- Workforce Training, Local Hire Commitment & Workplace Safety: We need to promote, reward and advance local workforce training programs as part of contract awards and ensure we are truly deploying local hire efforts through our procurement process. Further, our commitment to partner with the private sector must include the highest standards for workplace safety and worker protections. Through our procurement process, contract awards should reflect these core objectives and reward businesses that clearly outline their protocols.
- **Support Diversity:** While Miami-Dade County government procurement continues to make enormous strides towards supporting diversity, I believe we can always do more. There are several ways in which we can continue to tap into the pool of talent that comes from our diverse community, especially lifting up existing minority businesses. This is a challenge and an opportunity we should lean into and embrace because our success as a community depends on our ability to engage everyone in our labor force and ensure all families can prosper.
- Resiliency & Energy Efficiency: As we more aggressively address climate change and invest in robust sea level rise mitigation strategies, we need to ensure that our infrastructure is resilient and the way we deliver services. We should position our County to be energy efficient and our contracts should work towards reducing our carbon footprint. We need to

look at how items going through the procurement process can help us accomplish these important environmental safeguards, and prepare us to continue serving our residents well into the future with the greatest possible energy efficiency.

- **Forward Looking:** As we emerge from the COVID-19 pandemic, we need to reassess the way that our economy has changed and will continue to change. All country procurement needs to look at how we have evolved as a government and community, take into account the impact of COVID-19 in our future operations, and make sure that new approaches and innovation to providing or delivering services are part of our procurement process.
- **Efficiency:** We should leverage our procurement expertise to increase efficiencies and reduce the time it takes to arrive from need to solution. We need to set real benchmarks to identify the places in the process where we can more efficiently use our resources to serve residents.

#### Recommendation

I recommend that the Board of County Commissioners approve the attached resolution rejecting all proposals received by Miami-Dade County, through the Aviation Department, in connection with ISD Project No. A18-MDAD-01 entitled "Capital Improvement Program Specialized Services." The scope of work for these specialized services includes but is not limited to: project scope verification; project design development; development and management of MDAD's Capital Improvement Program (CIP) master schedule; task schedules and budget/cost oversight of project elements; project management; tracking and reporting of contracts and projects status; daily inspections and logs; documentation of daily progress and quality of construction work; strategic day-to-day oversight and direction for the CIP and specific projects; propose mitigation and solutions for certain projects; prepare and maintain a program management plan; and provide cost estimates and schedule of values.

On December 16, 2019, a Notice to Professional Consultants (NTPC) was issued under full and open competition to retain two Archirectutral/Engineering (A/E) Consultants for ISD Project No. A18-MDAD-01. These A/E firms will provide specialized services at Miami International Airport (MIA) under two separate non-exclusive professional services agreements, each with a 25 percent Disadvantaged Business Enterprise goal, a term of five years and two five-year renewal options in an amount not to exceed \$25,000,000 for the initial term, and an additional \$3,750,000 for each option to extend. Five proposals were received in response to the solicitation.

The First-Tier meeting was held on November 6, 2020. The Competitive Selection Committee (CSC) scored all responsive and responsible proposals and by majority vote invited the four highest ranked proposers to advance to the Second-Tier phase. The Second-Tier meeting was held on December 7, 2020, at which time the two highest ranked firms were recommended for negotiations by the CSC. On January 25, 2021, the request to initiate contract negotiations with the two highest ranked firms was submitted for approval by the Internal Services Division (ISD).
