

RESOLUTION CONGRATULATING THE COLLEGE
FOOTBALL PLAYOFF SELECTION COMMITTEE FOR
RIGHTLY SELECTING THE UNIVERSITY OF MIAMI
FOOTBALL TEAM OVER THE UNIVERSITY OF NOTRE
DAME FOOTBALL TEAM TO PLAY IN THE 2025 COLLEGE
FOOTBALL PLAYOFF

WHEREAS, the National Collegiate Athletic Association (NCAA) Division I Football Bowl Subdivision (FBS) is widely recognized as the highest level of college football in the United States; and

WHEREAS, under the current FBS system, 12 teams are annually invited to participate in the College Football Playoff (CFP), a post-season tournament to determine the FBS national champion; and

WHEREAS, the CFP Selection Committee decides, using certain objective and subjective criteria, which 12 teams will be invited to participate in the CFP; and

WHEREAS, on September 1, 2025, the University of Miami (Miami) Hurricanes football team hosted the University of Notre Dame (Notre Dame) Fighting Irish football team at the Hard Rock Stadium located in Miami Gardens, Miami-Dade County, Florida; and

WHEREAS, in that game, Miami defeated Notre Dame by a score of 27 points to 24 points; and

WHEREAS, despite a close numerical score, many analysts think that Miami played with a higher level of physicality in that match, and controlled the game on both offense and defense for the vast majority of the four quarters; and

WHEREAS, despite having identical records towards the end of the 2025 season, the CFP Selection Committee ranked Notre Dame above Miami for several weeks; and

WHEREAS, both teams finished the 2025 college football season with 10 wins and 2 losses; and

WHEREAS, many analysts agree that both teams had comparable schedules in terms of the quality of opponents faced; and

WHEREAS, Miami's late-season victories showcased their ability to perform under pressure, including a nationally televised win that solidified their playoff credentials; and

WHEREAS, several analysts observed that Miami's defense ranked higher nationally in sacks, turnovers forced, and red-zone efficiency than Notre Dame's; and

WHEREAS, Miami's roster depth, coaching adjustments, and player development were widely credited with propelling them past Notre Dame in both statistical and qualitative performance; and

WHEREAS, on December 7, 2025, the CFP Selection Committee ranked Miami higher than Notre Dame and thereby invited Miami to participate in the College Football Playoff; and

WHEREAS, this Board desires to congratulate the CFP Selection Committee for rightly selecting University of Miami over Notre Dame to participate in the 2025 College Football Playoff,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board congratulates the College Football Playoff Selection Committee for rightly selecting the University of Miami football team over the University of Notre Dame football team to play in the 2025 College Football Playoff.

The Prime Sponsor of the foregoing resolution is Commissioner Oliver G. Gilbert, III. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:
