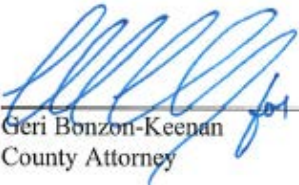

RESOLUTION NO. _____

RESOLUTION CODESIGNATING THAT PORTION OF S.W.
58TH STREET BETWEEN S.R. 985/S.W. 107TH AVENUE AND
S.W. 102ND AVENUE AS “SONIA CASTRO WAY”

WHEREAS, starting in 2003, Sonia Castro was an active participant in the County’s community affairs, having assisted in several campaigns at the county and state level, including legislative and judicial races; and

WHEREAS, Sonia Castro later became the Director of Constituent Services for County Commission District 6 under then-Commissioner Kevin Marino Cabrera, where she had a lasting influence in County government; and

WHEREAS, Sonia Castro passed away in May of 2024, and will be remembered for her commitment to public service and her positive impact in the Miami-Dade County community; and

WHEREAS, during the 2025 regular session, the Florida Legislature provided an honorary designation for Sonia Castro in commemoration for her career in public service at Miami-Dade County; and

WHEREAS, that portion of S.W. 58th Street between S.R. 985/S.W. 107th Avenue and S.W. 102nd Avenue is a County-maintained road located in unincorporated Miami-Dade County; and

WHEREAS, this proposed codesignation is located in County Commission District 10; and

WHEREAS, this Board wishes to honor Sonia Castro’s memory and legacy by codesignating that portion of S.W. 58th Street between S.R. 985/S.W. 107th Avenue and S.W. 102nd Avenue as “Sonia Castro Way”,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having considered this matter at a public hearing, codesignates that portion of S.W. 58th Street between S.R. 985/S.W. 107th Avenue and S.W. 102nd Avenue as “Sonia Castro Way”.

Section 2. Directs the Clerk of the Board to send certified copies of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade Sheriff’s Office, and the Miami-Dade County Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Chairman Anthony Rodriguez. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:
