RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE NOVEMBER 3-4, 2006 FATHERS & SONS CAMPOUT AND ROYAL RANGERS ROUND-UP SPONSORED BY THE UPPER ROOM ASSEMBLY OF GOD, A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$716.00 TO BE FUNDED FROM THE COUNTYWIDE IN-KIND RESERVE FUND

WHEREAS, the Upper Room Assembly of God has requested in-kind services from the Miami-Dade Park and Recreation Department for the November 3-4, 2006 Fathers & Sons Campout and Royal Rangers Round-Up in an amount not to exceed \$716.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the Upper Room Assembly of God is a not-for-profit organization; and

WHEREAS, the Fathers & Sons Campout and Royal Rangers Round-Up is a small event, as defined in the attached Fee Waiver/In-kind Service Application, with the purpose of providing an overnight camping experience designed to build relationships, inspire, and mentor those in attendance; and

WHEREAS, the in-kind services shall be funded from the Countywide In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department for the November 3-4, 2006 Fathers & Sons Campout and Royal Rangers Round-Up in an amount not to exceed \$716.00 to be funded from the Countywide In-kind Reserve Fund.

Subject: District Specific In-Kind Reserve Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization Upper Room Assembly for their "Father & Sons" Campout held on November 3 and 4, 2006.
