DEDICATION AND IMPROVEMENT AGREEMENT

WHEREAS, Conrado Lopez whose address is 1925 Brickel Ave, Miami #1604, Florida 33129, hereinafter referred to as the **OWNER, is the owner of the following described property:**

The West 172.2 feet of the North ½ of Tract 8, of "J. L. WADDY SUBDIVISION", according to the plat thereof, as recorded in Plat Book 3, Page 104, of the Public Records of Miami-Dade County, Florida.

AND WHEREAS, the said OWNER desire to develop this property in a manner that requires him by law to dedicate and improve a public right-of-way for SW 197th Avenue and SW 334th Street in order to obtain a building permit.

AND WHEREAS, the Director of the County Department of Public Works, hereinafter referred to as the **DIRECTOR, recommends that a building permit not be issued unless the **OWNER** obligates himselfe to immediately dedicate and, at a later time, construct half of the full width for road for SW 197th Avenue and SW 334th Street in accordance with County standards;**
