RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT AND THE MIAMI-DADE POLICE DEPARTMENT FOR THE NOVEMBER 18, 2006 4TH ANNUAL PUERTO RICAN FESTIVAL SPONSORED BY ASPIRA SOUTH, A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$2,583.85 TO BE FUNDED FROM THE COUNTYWIDE IN-KIND RESERVE FUND

WHEREAS, ASPIRA South has requested in-kind services from the Miami-Dade Park and Recreation Department and the Miami-Dade Police Department for the November 18, 2006 4th Annual Puerto Rican Festival in an amount not to exceed \$2,583.85 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, ASPIRA South is a not-for-profit organization; and

WHEREAS, the 4th Annual Puerto Rican Festival is a special event, as defined in the attached Fee Waiver/In-kind Service Application, and in-kind services shall be funded from the Countywide In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department and the Miami-Dade Police Department for the November 18, 2006 4th Annual Puerto Rican Festival in an amount not to exceed \$2,583.85 to be funded from the Countywide In-kind Reserve Fund.





Subject: Countywide In-Kind Reserve Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The countywide in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization ASPIRA of Florida, Inc. for their 4th Annual Puerto Rican Festival held on November 18, 2006.

In-kind services have been requested in an amount not to exceed \$1,867.85 from the Miami-Dade Police Department for police services and \$716 from the Park and Recreation Department for use of the stage for a total in-kind amount of \$2,583.85.

In FY 2006-07 Aspira of Florida has not received any funding for this event.
