WHEREAS, this Board considers a statewide outreach and public awareness campaign focused on capturing wanted violent criminals and closing unsolved criminal drug cases worth funding and implementing in an effort to decrease the incidences of violence and drug activity and improve the safety of Floridians,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Urges the Florida Legislature and the Florida Department of Law Enforcement ("FDLE") Commissioner to fund and implement an outreach and public awareness campaign to seek the public's assistance to apprehend violent offenders and close unsolved criminal drug cases.

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Governor, Senate President, House Speaker, Chair and members of the Miami-Dade County State Legislative Delegation and the FDLE Commissioner.
