RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE FEBRUARY 1, 2007 JAZZ ON THE LAWN EVENT SPONSORED BY MIAMI CAROL CITY SENIOR HIGH SCHOOL, A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$761.00 TO BE FUNDED FROM THE DISTRICT 1 IN-KIND RESERVE FUND

WHEREAS, Miami Carol City Senior High School has requested in-kind services from the Miami-Dade Park and Recreation Department for the February 1, 2007 Jazz on the Lawn event in an amount not to exceed \$761.00 (see attached Fee Waiver/In-Kind Service Application); and

WHEREAS, Miami Carol City Senior High School is a not-for-profit organization; and

WHEREAS, the Jazz on the Lawn event is a special event, as that term is defined in the attached Fee Waiver/In-Kind Service Application, and the purpose of the event is to introduce parents, students, school staff and the community to Miami Carol City Sr. High's Small Learning Communities; and

WHEREAS, the in-kind services shall be funded from the District 1 In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department for the February 1, 2007 Jazz on the Lawn event in an amount not to exceed \$761.00 to be funded from the District 1 In-kind Reserve Fund.


